

A Note to the Reader

How would you solve the greatest (unsolved) crime of all time, if you were Sherlock Holmes, English literature's most famous detective, and one of the most ingenious characters ever created? Described by his partner, Dr. John H. Watson, as "patriotic, courageous, tenacious and loyal, with the mind of a computer, Holmes appeared to know every detail of every horror perpetrated in the past century." Imagine if Sherlock Holmes (and his trusty partner Dr. Watson) were called upon, in modern times, to help solve the crime of 9/11.

Watson: "Holmes, why do you say 9/11 is the greatest ^{unsolved} crime of all time?"

Sherlock Holmes: Well Watson, 9/11 may not be the *greatest* crime of all time – there have been many crimes that would rival or surpass 9/11 in terms of casualties and suffering. And, of course, the Bush administration claims the case is closed because they know who *did* 9/11 – Osama bin Laden and the 19 al Qaeda hijackers. But, let's not jump to conclusions. In the court of world opinion, there isn't a consensus on Bush's 'conspiracy theory' – not even close. Almost half of those who know anything about it, don't buy it – including the Federal Bureau of Investigation!

According to the FBI, there isn't enough evidence to pin 9/11 on Osama bin Laden. I'll give you two quotes to prove it: On April 30, 2002, FBI Director Robert Mueller stated, "In our investigation, we have not uncovered a single piece of paper ... that mentioned any aspect of the September 11 plot." Chief of Investigative Publicity for the FBI, Rex Tomb, stated on June 5, 2006, and I quote: "The reason why 9/11 is not mentioned on Usama Bin Laden's Most Wanted page is because the FBI has no hard evidence connecting Bin Laden to 9/11."

Given then, that the FBI doesn't agree with the official story, as put forth by the Bush administration, one could say the crime of 9/11 remains *unsolved*. And given that it has had *dramatic* implications for millions of people around the world, you could say it's the *greatest* unsolved crime of all time.

Watson: So you don't believe the Bush administration's own ^{official} account?

Holmes: Not at all Watson. Just listen to it: *19 Muslim extremists, directed by Osama bin Laden from a cave in Afghanistan, hijacked four US commercial passenger jets on September 11, 2001 using only knives and box cutters. They evaded the entire multi-billion dollar US defense system and using the planes as bombs, they successfully crashed them into three out of four targets. World Trade Centers 1 and 2, in New York, collapsed within two hours of being hit – due to the impact of the planes, the explosion of their fuel and the subsequent office fires. All 156 passengers on board died on impact. Both of the 110-storey Twin Towers collapsed in a 'pancake' fashion, pulverizing everything in their path, killing approximately 2700 persons in and around the complex. A third 47-storey skyscraper, WTC Building 7, collapsed later that day due to damage sustained by falling debris from the Twin Towers. One person was killed. The plane that hit the Pentagon in Washington, DC, vaporized on impact, killing 125 people on the ground and 64 passengers on board. The fourth plane, which never reached its target, crashed near Shanksville, Pennsylvania due to a passenger revolt, killing all 45 passengers on board. There were no warnings for this act of terrorism, and it was a series of unfortunate communication failures that prevented an adequate defense.* ... However, Watson, this story, in my opinion, is riddled with inconsistencies and it is clearly problematic.

Watson: How so, Holmes? What's your alternative theory? And how are you going to prove the official account is a lie?

Holmes: The alternative? That remains to be seen. As to *how* to prove the official theory is absurd – elementary, my dear Watson – simply by following the usual principles we always use in the art of detection.

Watson: So, the big question remains: WHO DUNNIT?

Holmes: Patience, my dear Watson. We shall soon see.

20 Tips from *Sherlock Holmes* on the Art of Detection



Sherlock Holmes

Stick to the Facts. Eliminate the Impossible.

1. Stick to the facts. Insensibly one begins to twist facts to suit theories, instead of theories to suit facts. (SCAN)
2. It is of the highest importance in the art of detection to be able to recognize out of a number of facts which are incidental and which vital. Otherwise your energy and attention must be dissipated instead of being concentrated. (REIG)
3. There is nothing more deceptive than an 'obvious' fact. (BOSC)
4. There is nothing like first-hand evidence. (STUD)
5. It is a capital mistake to theorize before you have all the evidence. It biases the judgment. (STUD)
6. To solve the mystery, first look for he who will benefit. (THOR)
7. Never trust to general impressions, my boy, but concentrate yourself upon details. (IDEN)
8. One should always look for a possible alternative and provide against it. It is the first rule of criminal investigation. (BLAC)
9. We must look for consistency. Where there is want of it, we must suspect deception. (THOR)
10. We balance probabilities and choose the most likely. It is the scientific use of the imagination. (HOUN)
11. I never make exceptions. An exception disproves the rule. (SIGN)
12. There is no branch of detective science which is so important and so much neglected as the art of tracing footsteps. (STUD)
13. Where a crime is coolly premeditated, the means of covering it up are coolly premeditated also. (THOR)
14. When you have eliminated all which is impossible, then whatever remains, however improbable, must be the truth. Improbable as it is, all other explanations are more improbable still. (BLAN) (SILV)
15. Circumstantial evidence is a very tricky thing. It may seem to point very straight to one thing, but if you shift your own point of view a little, you may find it pointing in an equally uncompromising manner to something entirely different. (BOSC)
16. It has long been an axiom of mine that the little things are infinitely the most important. (IDEN)
17. Crime is common. Logic is rare. Therefore it is upon the logic rather than upon the crime that you should dwell. (COPP)
18. Detection is, or ought to be, an exact science and should be treated in the same cold and unemotional manner. (SIGN)
19. I never guess. It is a shocking habit – destructive to the logical faculty. (SIGN)
20. One true inference invariably suggests others. (SILV)





Preface

There are many reasons I came to doubt the official story of 9/11 – one of the biggest was the fact that the FBI's MOST WANTED POSTER of 'Usama' bin Laden didn't mention he was wanted for the crime of 9/11. (See p. 14.) Therefore, I concluded, the Bush administration's official story of 9/11 had at least one very large hole in it. As an activist and publisher, I wanted to find out what really happened on 9/11, and then expose the real criminals behind, what many consider to be, the greatest (still unsolved) crime of all time.

On the morning of September 11, 2001, I was driving home from my girlfriend's. I thought I'd swing by the carpet cleaners to pick up a carpet. At about 8:55 a.m. I tuned into the CBC radio morning show. Just as I did, I heard the commentator, Andy Barrie, say something about looking at a "big black hole in the World Trade Center in New York." I kept on driving, wondering what he could have meant. He reported that an airplane had just crashed into one of the Twin Towers in New York. "My God!" I thought. "It must have been an accident – due to poor weather perhaps."

As I pulled into the carpet cleaners, I asked John, the owner, if he'd heard the news. No, he hadn't, but he immediately turned on a small black and white television set in his office and we looked in disbelief at the smoke billowing forth from the North Tower.

"What's the first thing that comes to mind?" he asked. "Pilot error," I replied. "Nope, terrorists!" he exclaimed. I looked at him and gulped. That very moment, just as we turned our eyes back to the TV, we saw the second plane crash into the South Tower. I just about fell over in disbelief, and so did he. We both stood there dumbfounded.

I dashed out of there almost forgetting my carpet and drove straight home thinking, "Yes, of course, terrorists! It had to be. Two planes, two direct hits!" On the way home, I phoned my girlfriend at work to see if she'd heard the news. Yes, and she couldn't believe it either. We both agreed it was unbelievable – surreal, in fact. We quickly made plans to get together at my place as soon as she was finished work.

This, of course, was earth shattering news for everyone, everywhere. I spent the next 10 or 12 hours watching those images, over and over again, on TV, and later, in my mind's eye, as I tossed and turned in my sleep. "Terrorists?" I said to myself. "How could they get away with it?"

As for who exactly *they* were I wasn't quite sure. But it only took a couple of hours after the attacks for the Bush administration to say there were 'good indications' it was Osama bin Laden, a Saudi nationalist, living in Afghanistan.

That accusation seemed a little suspicious. Just like the FBI arresting Lee Harvey Oswald within hours of JFK's assassination – it was pretty darned convenient.

Within 72 hours they announced the names of the 19 so-called hijackers, even though they claimed they had no idea that an attack was imminent. Somehow I felt the government's story was just too slick. It seemed to be right

out of Hollywood. "How could 19 fanatic Arab hijackers pull off such a stunt orchestrated by some guy from a cave in Afghanistan? Impossible!" I thought.

Later when talking with my friends, it seemed that they were equally suspicious. Some believed that a huge hoax had been perpetrated on all of us by members of the Bush administration. Now *that* seemed unbelievable! Or was it?

I had been publishing *Monetary Reform* magazine since 1996. On October 1, 2001, I published what would become the last issue of *Monetary Reform* (#11). In it was an editorial on how I felt the US should respond to these attacks. I quoted the Dalai Lama, Maude Barlow, Noam Chomsky, three South African Nobel Peace Prize Laureates (de Klerk, Mandela and Tutu), and Michael Parenti, all of whom had the same sensible idea of finding the perpetrators (whomever they might be) and bringing them to justice – not shooting first and asking questions later, as President Bush was intent on doing. Just six days later, on October 7th, the US and its ally, Britain, invaded Afghanistan supposedly to go after Osama bin Laden.

The hasty US response made sense to me at a dinner party in Toronto on October 13th, when a friend of mine, told me that Pearl Harbor was *not* a surprise attack. He had read a book about it and recommended I read John Toland's *Infamy: Pearl Harbor and Its Aftermath*. I also checked out Robert Stinnett's *Day of Deceit*. Both proved to me that the Pearl Harbor attack was allowed to happen on purpose by President Franklin Roosevelt, as a pretext to get involved in WWII. (See story ps. 18-21.)

Since I was in the business of publishing magazines, my friends and I discussed the idea of creating a special *Stop the War* issue of a single issue magazine, to expose the great deception of 9/11 and thereby put an end to the reason for the war in Afghanistan.

By November 2001, after much research and consulting with other researchers, I began assembling articles which proved 9/11 must have been a false flag operation. If the US government had done it before, with Pearl Harbor (when they sacrificed nearly 3000 American lives), they could do it again! They had the means (remote control technology to fly the planes and the patsies to blame it on), the motive (the need to control the Middle Eastern oil supply which was up for grabs after the fall of the Soviet Union) and the opportunity (Bush, being the perfect neocon puppet who was ready, willing and able to become a popular war time president.) For me, that was one 'conspiracy theory' that made sense, but I needed more feedback on publishing such a controversial magazine.

So, I created an 8½ x 11 inch handout that would get my message across expressing my doubts about the veracity of the ‘official 9/11 story.’ My handout was entitled: *How Do You Explain The Following 5 Anomalies?* (See it on ps. 8 and 17.)

I handed out 30 copies of the flyer after a speech by Gwynne Dyer (a military historian) at Georgian College, in Barrie, Ontario on November 7th, where I confronted him during the Q&A with what I thought was the real reason for the US invasion of Afghanistan: to secure the oil pipeline route denied to Unocal by the Taliban. But he didn’t buy it. I mentioned three of the anomalies on the handout including Operation Northwoods (see description ps. 15-17) of which he claimed he had never heard. (That’s when I first ran into the stone wall called ‘denial.’) You would think that a military historian would know about Operation Northwoods – but apparently he didn’t.

Next I attended a Town Hall Forum on November 19th at the Toronto City Hall. The forum addressed the coming restrictions to our civil liberties as a result of 9/11 and a new Bill (C-36) being debated in the Canadian Parliament similar to the US PATRIOT Act. I handed out about 150 flyers to various attendees, including Naomi Klein, Howard Hampton and media critic, Barrie Zwicker. Barrie, spontaneously asked me if I would like to collaborate with him on a new show for Vision TV: *The Great Deception*. I agreed and we soon became good friends and fellow activists in what later became known as the 9/11 Truth movement.

* * *

Shortly afterwards (in the Spring of 2002) I published the first issue of *Global Outlook* with the help of two assistants and some dedicated friends.

The magazine started out as a quarterly covering a wide range of international issues from the Palestinian-Israeli conflict to the attempted overthrow of Hugo Chavez by the Bush administration back in 2002. By the time Issue #9 came out, I decided to focus almost entirely on cracking the 9/11 fraud: that is, proving to a critical mass of (mainly American) people that *9/11 was a huge hoax*. No one else in the magazine business seemed to be doing it, so I felt it was greatly needed. There were plenty of other magazines that were doing a decent job of covering the other issues.

Over the next six years of our publishing history we encountered more than enough challenges but thanks to all our donors, subscribers and customers, we survived and eventually we became known as “The Magazine of 9/11 Truth” which we proudly adopted as our logo.

During that time (back on Jan. 9, 2004), co-editors Barrie Zwicker, Terry Burrows and I, along with several others, founded a non-profit organization called SIFT – Skeptics Inquiry For Truth (www.911Inquiry.org) to host an

International Citizens’ Inquiry into 9/11 in Toronto in May of 2004. It was a qualified success with well over 30 presenters, but it only attracted 300 participants. However, it was videotaped so we were able to spread our message by DVD all around the world. There have been many such conferences since and *Global Outlook* has covered most of them.

* * *

What you will read here are the best articles that appeared in the first ten issues of *Global Outlook*, specifically on the key subject of 9/11. The other issues which we covered were important, I agree, but 9/11 is the linchpin upon which most of the other issues we were covering are based.

We are publishing this volume for the historical record and to show how the alternative views of 9/11 evolved and why they have now been catapulted to the forefront of today’s politics.

As one subscriber put it: “[B]ecause of the monstrous things that 9/11 is being used as an excuse for, 9/11 is the crucial issue now, the most important issue.”

The collective trance induced by the mainstream media who still support the official story has been

hard to break, but there are signs that we are reaching a critical mass. Sooner or later a new, entirely independent investigation into the crime of 9/11 will have to take place, to clear the air, and then the floodgates will open to what we call 9/11 Truth. After reading this compendium I’m sure you will agree that the US government’s story of what happened on 9/11 is a hoax and therefore, WE MUST DO EVERYTHING WE CAN TO DEMAND A NEW, INDEPENDENT INVESTIGATION INTO 9/11 before going on. Our future depends on it.

Questions for the Town Hall Forum – November 19, 2001 – Toronto City Hall

How Do You Explain the Following 5 Anomalies?

1. OPERATION NORTHWOODS –

Shortly after the failed *Bay of Pigs** invasion of Cuba by the US (April 1961), the Joint Chiefs of Staff all signed a document which the then Defense Secretary of the United States, Robert McNamara, presented to President Kennedy (in March 1962). It stated that the US military was willing to orchestrate violent acts of terrorism in US cities, or blame the potential death of John Glenn, the astronaut, on Cuba in order to trick the public into going to war to oust Cuba's new leader, Fidel Castro. [Reference: *Body of Secrets* (Doubleday) by James Bamford – 2000. See also, back of flyer, p. 17.]

What evidence do we have that the Joint Chiefs of Staff think any differently today? Would they still be willing to inflict casualties on American citizens, if need be?

2. PEARL HARBOR –

Why does virtually no one in the United States (or Canada) know that President Roosevelt had prior knowledge of the attack on Pearl Harbor – and did nothing about it? This is a well-documented fact, by a well-respected American historian, John Toland – but not at all well known. Doesn't that change your perspective on the so-called "Day of Infamy" at Pearl Harbor? [Refc.: *Infamy* by John Toland – See summary ps. 18-19.]

Is it possible that President Bush had prior knowledge of the September 11th attacks and did nothing?

3. THE REICHSTAG FIRE –

Why is it that most people seem to have forgotten what started World War II ... Do you remember the burning down of the Reichstag** – the German Parliament buildings on February 27, 1933? Hitler blamed his enemies which, in turn, roused the German people. By 1939, Germany was at war with all its 'so-called' enemies. Remember Hitler's quotation, "The great masses of people ... will more easily fall victims to a big lie than to a small one." History later reports that "the big lie" was the fact that Hitler, *himself*, caused the burning down of the Reichstag! [See p. 206.]

Did Bush & company know in advance of the attacks on the Twin Towers, Sept. 11 and fail to take action, in order to manufacture enough consent to go to war in the Middle East?!

4. MAINSTREAM MEDIA MONOPOLY –

Why is the mainstream media complicit in supporting the invasion of Afghanistan? Why do the mass media accept the official story without question? Perhaps because, in the US, media concentration has ended up with only six corporations owning 90% of the media. [See *Global Outlook*, Issue #12, especially p. 2.]

Are the mainstream media complicit with the Bush administration by not questioning the official 9/11 story? And are they not part of the cover-up?

5. BILL C-36 AND THE US PATRIOT ACT –

Will the new anti-terrorism legislation (Bill C-36) that is coming into effect before Christmas, here in Canada, include George Bush's New Summary Courts? "The shocking US Presidential Executive Order of Tuesday, November 13 sets up special military courts and sets the stage for arrests on very broad and vague grounds. It also permits virtually unlimited secret detention in which the detained persons have no right to legal counsel and no right to knowledge of accusations brought against them. The order allows initial sentences to stand without any possibility of appeal.

Though the United States media have issued only restrained reports about the order, all those involved in human rights and civil liberties work are appalled at how far it goes and what a threat it poses to established Constitutional guarantees, especially when taken together with other recent anti-terror legislation such as the US PATRIOT Act.

Human Rights Watch, in a letter to the President on November 15 expressed its 'profound concern' and concluded that it is "wrong and unlawful for the US government to arrogate [claim] to itself the power to transgress these well established protections of international human rights law."

The next day, the normally circumspect *New York Times* went further. In a lead editorial entitled "A Travesty of Justice," it denounced the order as "a breathtaking departure from due process" and "a crude and unaccountable system that any dictator would admire." [Refc.: Global Policy Forum List-Serv, Nov 12-16 text]

Is not the Canadian government walking down the same path as the Bush administration by using this crisis to criminalize dissent – to turn concerned citizens into terrorists – and to kill any future protests, including the swelling 'anti-globalization' movement, and the global 'peace movement'? [See ps. 85, 97-99, 158-159.]



Solving **Holmes' 9/11 Summation: the Greatest Crime of All Time**

Dr. Watson: It's very important that this monstrous crime and great deception be exposed as soon as possible, don't you think Holmes?

Sherlock Holmes: Yes, of course.

Watson: Well then Holmes, having reviewed all the evidence, have you figured it out yet?

Holmes: Yes, indeed. But before I point any fingers, I thought you'd be interested in knowing how I arrived at my conclusions.

Watson: Quite so, Holmes. So how then did you solve the crime of 9/11?

Holmes: By following our principles, dear Watson:

1. Stick to the Facts: For example: There wasn't an adequate military fighter response to prevent the targets from being hit – and there should have been one. On June 1, 2001, just three months before 9/11, a new Pentagon directive, CJCSI 3610.01A, required that all requests to NORAD for intercepting hijacked airliners be approved by the Secretary of Defense, Donald Rumsfeld. Rumsfeld admitted that, even though he was at the Pentagon, he was 'out of the loop' for more than two hours after the FAA became aware of the first hijacking. He didn't arrive at the National Military Command Center or join the Air Threat Conference Call until 10:30 a.m., half an hour *after* the last hijacked plane had crashed.

Further facts: On May 8, 2001, the President put Cheney in charge of all war games including any NORAD training drills. There were at least five different war games going on during the attacks of 9/11. By 9:15 am, 12 minutes after Flight 175 struck the South Tower, Cheney was in the Presidential Emergency Operations Center (PEOC), under the White House, running a command, control and communications system which superseded that of the National Military Command Center at the Pentagon. The US Air Force had 1 hour and 46 minutes to respond to the four reported hijackings, three of which went on to hit their targets. Neither Secretary Rumsfeld nor Vice President Cheney resigned or was reprimanded. No military commander was disciplined.

2. Be able to recognize facts which are incidental as opposed to those which are vital: After the Bush administration took power, it lied about Iraq having WMDs and that there was a link between Saddam Hussein and 9/11, to justify invading Iraq. But this is incidental to our case. What is vital is the fact they planned the Iraqi 'regime change' before even taking office. The Project for a New American Century group, formed in 1997 by Cheney, Rumsfeld, Wolfowitz and others, sought US world domination through control of oil-rich Central Asia. Their 2000 paper *Rebuilding America's Defenses* said all they needed was a "catalyzing event – like a new Pearl Harbor" to mobilize enough public support to launch their imperial wars of conquest. This provides a motive for the 9/11 crime.

3. There is nothing more deceptive than an obvious fact: The passport belonging to one of the so-called hijackers, Satam Al-Suqami, that was found in the rubble of the World



Trade Center, was obviously planted there by someone. How else could it have withstood the inferno of 9/11? Also, the flight manual, the Koran and Mohamed Atta's will, which were found at Logan Airport by the FBI in a car rented by Atta, are equally suspicious.

4. There is nothing like first-hand evidence: On May 23, 2003, Secretary of Transportation Norman Mineta gave the 9/11 Commission some of its most important eyewitness testimony. He described being

with Vice President Cheney in the PEOC during the time of the hijacked planes' attacks: 'A young man came repeatedly to report, "The plane is 50 miles out." "The plane is 30 miles out." And when it got down to "the plane is 10 miles out", the young man asked, "Do the orders still stand?" Cheney whipped his neck around and said, "Of course the orders still stand. Have you heard anything to the contrary?"' Now if the order was to "shoot down the incoming plane," there would have been no need for the young man to keep asking the obvious question. The conversation only makes sense if Cheney meant: "Don't shoot it down!" What did the 9/11 Commission do with that crucial first-hand testimony? *They omitted it from their report!*

5. Don't theorize before you have all the evidence: The Bush administration declared who their prime suspect was – Osama bin Laden – within hours of the attacks. They had the names of the 19 so-called hijackers within 72 hours. Yet, right after 9/11, they claimed they had 'no idea' that anyone was planning such an attack. So how did they get their names so quickly? Also, when the Taliban said they would extradite Osama to the US if the US could prove to them that Osama in fact did it, the Bush administration refused and then invaded Afghanistan anyway, supposedly to get bin Laden.

6. First, look for he who will benefit. There have been huge budget increases for the military, the CIA, the FBI, the NSA and Homeland Security. President Bush immediately became a popular war-time president. Cheney's former company Halliburton made astronomical profits with no-bid contracts in Iraq. Even though he is Vice President, Cheney still holds large stock options in his former company.

7. Concentrate on the details, not general impressions: The spectacular collapse of the Twin Towers shocked the world. Endless reruns seared their destruction into everyone's mind. The seemingly plausible explanation that burning jet fuel had so weakened them that they collapsed in a 'pancake' fashion was supplied immediately. But detailed examination revealed they collapsed at near free-fall speed. Buildings collapsing into the path of most resistance don't fall at free-fall speed. And they don't disintegrate into dust in mid-air and smoulder underground for weeks simply because of burning jet fuel.

Similarly with Building 7: though not hit by a plane, it also collapsed at free-fall speed into its own footprint at 5:20 p.m. The government claims it was carved out by falling debris

from the collapse of WTC 1 and 2, yet no photographs have been produced to prove this assertion. A 47-story steel framed skyscraper just doesn't collapse because of a few small office fires on the 7th and 12th floors. Even if it was carved out, as they say, it would have toppled *over*, not fallen straight down. Do the physics, dear Watson, it doesn't make sense.

8. Look for a possible alternative and provide against it. The alternative view offered by conspiracy analysts points the finger at US government cover-up and complicity on 9/11. In order to prove its story, the government must produce evidence it has been unwilling to provide, for example: the scores of video tapes of the Pentagon crash, substantial samples of the steel from the Twin Towers and Building 7, complete passenger lists, credit card and service provider records for all the 9/11 air phone and cell phone calls that they claim were made, sworn testimony by, among others, the President and Vice President, individually – not together, behind closed doors, and censored by the White House, as was the case when they 'testified' before the 9/11 Commission. None of this evidence has been made available. The alternative view – that it was an inside job – has much more supporting evidence.

9. We must look for consistency. Where there is want of it, we must suspect deception. Is the official story consistent? Why did President Bush, America's so-called Commander-in-Chief, just sit there reading the story about a pet goat at 9:05 a.m. for another 8 or 9 minutes when he was told by his Chief of Staff: "A second plane hit the Second Tower. America is under attack."? Tell me also, why did NORAD keep changing its story as to why they were unable to intercept any of the hijacked planes? Right after 9/11, they said no jets were scrambled until after the Pentagon was hit. Then, on September 14, they said they did, in fact, scramble jets before the strike on the Pentagon – but that they arrived too late. The third version of their story, given later to the 9/11 Commission, blamed the FAA for not notifying them in time. Yet, to date, no FAA personnel have been fired. When witnesses keep changing their story, we can assume they must be trying to cover something up.

10. Balance probabilities and choose the most likely. On 9/11, three steel-framed skyscrapers collapsed in free-fall, supposedly weakened by fire. This is most improbable. Prior to and since 9/11, no steel-framed skyscraper has ever collapsed like that. Numerous skyscrapers from Caracas, to Los Angeles, to Philadelphia have burned for much longer times and yet never collapsed.

11. Never make exceptions. An exception disproves the rule. According to the 9/11 Commission "it was of little practical significance who funded the attacks." But whatever happened to the old rule of thumb: "Follow the Money"? Was the funding of 9/11 an exception to the rule? I don't think so. The fact that it pointed fingers at Pakistan's ISI and then back at the CIA was probably the reason they ignored it. Not only that, but the SEC investigation into who had the foreknowledge to profit from all the put options placed on companies hurt by 9/11 was inexplicably suppressed.

12. There is no branch of detective science which is so important and so much neglected as the art of tracing footsteps. Now if you believe the official theory of how the World Trade Center buildings collapsed, we would have to go

back and revise several of the basic laws of physics: the law of momentum, the law of gravity and the laws of thermodynamics. However, if you believe, as I do, that prepositioned explosives were responsible for the destruction of all three, you will find that much more consistent with the physics.

13. Where a crime is coolly premeditated, then the means of covering it up are also coolly premeditated. Even Scotland Yard will tell you not to tamper with a crime scene until all the clues have been analyzed. But when we look at the 9/11 crime scenes you'll see the two main ones were destroyed – within hours, as in the case of the Pentagon site, or within days, as in the case of the World Trade Center site. This made examination of the key evidence impossible.

14. When you have eliminated all which is impossible, then whatever remains, however improbable, must be the truth. Now if you examine the Bush administration's official story line by line, you'll see that each and every one of its premises is virtually impossible: The premise that four slow-moving passenger planes could be hijacked simultaneously and somehow avoid being intercepted by hi-speed fighter jets over a period of an hour and 46 minutes. Two, the premise that the Twin Towers and Building 7 collapsed, as they did, without the use of pre-planted explosives. Three, the premise that the Pentagon was hit by an amateur pilot, Hani Hanjour, with military precision, after performing a 270° spiral turn. Four, that part of an engine could have bounced 300 yards away from the Shanksville crash site. Five, that the Bush administration had no idea there might be a terrorist attack within the United States, despite President Bush receiving such a warning on August 6, 2001 from his own intelligence people. And six, the premise that there were so many 'communication failures' all at once.

Discarding these impossibilities, I must conclude, by what remains, that certain individuals within the United States government were complicit in the crime of 9/11 and have been busy ever since covering it up. It's obvious that those involved were in positions of power and possessed the means, the methods and the opportunity to commit the crime of 9/11 in order to motivate Americans to go to their preplanned war in the Gulf.

Dr. Watson: What, then, Holmes do you say to those people who still believe the official story of 9/11?

Holmes: You see Watson, if they were to take the time to properly examine the evidence, they would see the official story is obviously based on false testimony, fabricated evidence, obstruction of justice, illogical arguments, leaps of faith, deliberate errors of omission of key evidence and a series of deeply flawed government sponsored reports to support their claims. Those, who care to look, can clearly see that the Bush administration's official story is *one big lie*.

Watson: Yes, Holmes, you've already said that, but you haven't answered the big question: Who dunnit?!

Holmes: Elementary my dear Watson. As I have been trying to tell you all along: 9/11 was an inside job – perpetrated by rogue elements within the United States government. The Vice President's fingerprints are all over it. Arrest him and all the other rogues will soon follow.



Epilogue – And Now to Catch the ^{Real} 9/11 Criminals

For those sleuths who have figured out “WHO DUNNIT?”, the next challenge is to figure out how to break the trance that holds us back from indicting the *real* criminals who committed the crime of 9/11. That now is the *real* work for 9/11 activists who want to see justice served and who want to stop the criminals from advancing their hidden agenda and executing another 9/11.

What are the obstacles and how can we overcome them?

1. General complacency amongst ourselves and our fellow citizens. However, we can't just stand by and watch as more and more innocent people are killed in the name of the *fraudulent* “war on terror.” If we are complacent, we are complicit in the crime of 9/11. Leaving it up to others ... that is, doing nothing about it, is a *big* part of the problem.
2. Widespread misinformation thanks to a complicit mainstream media which is censoring the quest for 9/11 Truth.
3. Public denial that criminal elements within the US government would even think about murdering 2700 or so of its own citizens to further its own agenda.
4. Denial that it would be possible to keep such a conspiracy under wraps. Critics say: “Where are all the whistle-blowers?” “Surely among the thousands involved in this crime, some of them would speak up?”
5. Belief that the Bush administration isn't smart enough to pull off such a huge covert operation.
6. The fact that Bush and company have convinced a majority of Americans that their suspects DID IT, means the case is closed for many.

WHERE'S THEIR EVIDENCE?

Why should we believe the official 9/11 story?

Colin Powell promised (on September 23, 2001) to give us a White Paper “describing quite clearly the evidence incriminating bin Laden” ... where is it?

Condoleezza Rice promised (on September 24, 2001) to provide us with “very good evidence of links” between bin Laden and 9/11 ... we are still waiting.

Bush and company have offered the following as evidence:

1. The FBI ‘found’ a passport belonging to one of the alleged hijackers at Ground Zero.
2. A Koran was found in a van rented to Mohamed Atta which was left abandoned at Logan airport.
3. Two of the 19 hijackers were videotaped going through a passenger check point at an airport.
4. A ‘bin Laden’ video ‘confessed’ to executing the attacks.
5. Khalid Sheikh Mohammed (KSM) confessed (under torture?) to being the US mastermind behind the crime.
6. 40 or so phone calls allegedly were made by the passengers on the 9/11 flights.
7. The remains of those on Flight 77, found at the Pentagon, were supposedly identified by DNA – including those of the hijackers.

All these flimsy bits of evidence have been discredited in this compendium or more recently at the 2006 Moussaoui

Trial which showed the famous calls from Todd Beamer and Jeremy Glick lasted way beyond the crash time into the thousands of seconds. (See the 2006 Moussaoui Trial exhibits and documents online at www.rcfp.org/moussaoui/.)

Why then can't the official story be deep-sixed right now?

We turn to the psychological problem of “Why Bad Beliefs Won't Die.” According to Gregory W. Lester the author of a paper on this subject, one of the reasons is this: our belief system is protected by the survival instinct of the human species. Otherwise we would be changing our beliefs at the drop of a hat. Here are some of our cherished beliefs that keep society sane. The problem, as you will see, is that most of these fundamental beliefs are imbedded in the official story.

1. Faith in our government's integrity – the government is there to protect us and would not murder its own citizens.
2. Faith in our political leaders – especially the President. Patriotism reigns supreme. Father knows best.
3. Faith in the mainstream media – television, radio, and print media are, for the most part, to be trusted.
4. Faith in our church leaders – if they believe the official story who is to say they are wrong?
5. Faith in society's system of checks and balances – democracy, freedom, open society and the public trust – prevents frauds of this magnitude, doesn't it?

Here are some ideas on how to break the trance – that is, reveal that the official story is a big lie:

- A. In conversation, when the term ‘conspiracy theory’ comes up, equate it with Bush's ‘official conspiracy theory.’
- B. Explain that sacrificing the lives of American citizens on 9/11 is not inconsistent with US psyops – like Pearl Harbor and false-flag ops – like Operation Northwoods.
- C. Recite all the lies the White House has been feeding us. (See YouTube's – “How to Create an Angry American.”)
- D. Rhyme off prominent 9/11 whistle-blowers who agree 9/11 was an inside job. (See PatriotsQuestion911.com.)
- E. Educate people about the countless contradictions that undermine the official story. (Study, for example, David Ray Griffin's new book, *9/11 Contradictions*.)
- F. Organize meet-ups, write articles, lobby legislators, and refuse to accept new laws ‘needed’ because of 9/11.
- G. Emphasize to people the supreme relevance that 9/11 Truth has to our future. Without it, we are doomed.
- H. Air as many 9/11 Truth videos/speakers on public access TV, C-SPAN, public radio, etc. as possible.
- I. Increase awareness to a critical mass that “9/11 was an inside job” by posting signs everywhere in solidarity.

So, if you have figured out *who really dunnit*, then why not put your skills to work by figuring out how to break this revelation to the masses – so that we can proceed to indict the *real* 9/11 criminals. Doing so would undoubtedly alter the course of history – in the same way the Nuremberg War Crime Trials did in 1945 – ushering in a new era of peace and reconciliation.

A graduate in landscape architecture, Ian Woods switched careers several times before entering the world of publishing and activism. He got 'bit by the bug' when he was touring Vancouver Island in 1993. He witnessed the largest act of civil disobedience in Canadian history at Kennedy River Bridge on August 9th. Approximately 300 people were arrested that day (a total of 859 in all) for opposing the clear-cutting of the old growth forest at Clayoquot Sound. That action saved the day for what remained of the majestic ancient rain forest.

In 1996, Woods joined forces with anti-corporate globalization activists from around the world launching his first activist periodical, *Monetary Reform*, to expose the corrupt debt-based money system in Canada, the US and the Western world and to fight the MAI (Multilateral Agreement on Investment). Many of the articles in *Monetary Reform* were dedicated to exposing the covert privatization of our money supply and the threat of the MAI "corporate rule treaty." The MAI was eventually defeated in 1998 thanks to the efforts of a worldwide network of over 600 grassroots activist organizations.

Woods also covered the protest at the Summit of the Americas held in Quebec City in the Spring of 2001. He and his friends were teargassed and shot at with rubber bullets by riot police. *Monetary Reform* put out a special edition (#11) which covered the protest and exposed the anti-democratic trade policies the G-8 governments were planning to sign and then globalize.

After the horrific events of 9/11, *Monetary Reform* (which had reached a circulation of 3,000) was replaced by *Global Outlook* which has focused on the fraud of both 9/11 and the ensuing "war on terror." This magazine became a forum for the 9/11 Truth movement. Woods became the president of a Toronto chapter named SIFT (Skeptics Inquiry For Truth – a.k.a. www.911Inquiry.org). SIFT produced the six-day International Citizens' Inquiry into 9/11 held in Toronto, May 25-30, 2004. (See list of topics and presenters on p. 338.) Six years and 12 issues later, *Global Outlook – The Magazine of 9/11 Truth* is still going strong with a circulation of 10,000. It is the only magazine in the world dedicated to solving the greatest crime of all time – 9/11. ■

Barrie Zwicker


Barrie Zwicker is an author, independent documentary film producer and political activist. He was the first journalist in the world to go on national TV to question deeply the official story of the events of 9/11, in a series of seven weekly commentaries beginning in January 2002. These were released as a 44-minute video, *The Great Deception*.

His latest work is the 416-page book *Towers Of Deception: The Media Cover-Up of 9/11*. Each copy of the book includes his 75-minute DVD, *The Great Conspiracy: The 9/11 News Special You Never Saw*.

In early 2002, Zwicker publicly dedicated the rest of his life to revealing the truth about 9/11. In the Fall of 2003, he became Director of the International Citizens' Inquiry into 9/11, Phase 2, held, in part, at The University of Toronto in May 2004. 40 presenters from 3 continents participated.

Zwicker has worked in journalism and communications since he was 16, working on major newspapers including *The Vancouver Province*, *Detroit News*, *Toronto Star* and *The Globe and Mail*. He taught journalism part time for seven years at Ryerson Polytechnic University. For 15 years he was the resident media critic with multi-faith channel *Vision TV*. In 1977, he founded *Sources®*, *The Directory of Contacts for Editors, Reporters and Researchers*. He also founded *Parliamentary Names & Numbers*.

He has been married to the same woman, Jean, for 43 years. In 1966 they gave up automobile ownership and Zwicker has ridden a bicycle ever since. ■



Two Contrasting Views – Which One is True?

On September 11, 2001 the world changed forever. Soon afterwards, two distinct groups of people emerged from that day with very different opinions as to what had happened.

One group adopted the official story released by the White House that four passenger planes were hijacked by 19 fanatic Muslim-Arab terrorists wielding knives and box cutters under the direction of Osama bin Laden using a laptop from a cave in Afghanistan. The official story of 9/11 has since been used by the Bush administration as justification for Bush's *War on Terror* which has resulted in two preemptive attacks by the US-UK-led "coalition of the willing": the first one taking place 26 days after 9/11 on Afghanistan and the second one, 17 months later, on Iraq. It also justified a huge increase in US and UK military spending, the clamp down on civil liberties at home and abroad, as well as a host of other life-changing policies, both foreign and domestic.

However, another smaller group has had great difficulty accepting the official story. Its members feel there are too many unanswered questions surrounding the events of 9/11 and too many anomalies which just don't add up. This small group has since mushroomed into a large "9/11 Truth movement." Six years later (as of publication date: 2007) there has been a worldwide explosion of disbelief in the "official story" and the alternative views about what may have happened on 9/11 have moved to the forefront of today's politics.

This book is an historical review of the birth of the 9/11 Truth movement from its inception in late 2001 to the summer of 2005. Based on the best articles (mainly on 9/11) printed in *Global Outlook* magazine over a four year period, it documents the accumulation of evidence which undermines the "official story" to a point whereby many now claim they have proven conclusively that 9/11 was (and is) a huge hoax perpetrated on the American people and the world by a nefarious criminal cabal in high positions of power.

Most of the original evidence revealed by the contributors in this book has now become the foundation upon which millions of skeptics worldwide believe the "official story" of 9/11 is ONE BIG LIE. If that indeed is so, then what really *did* happen on 9/11 and, more importantly, WHO DUNNIT?!






