REFUND/CANCELLATION POLICY

- 9. At any time after 6 months from the date of this Agreement, Customer may, after written notice, cancel this Agreement provided the following conditions have been met:
 - 25% of the negative remarks on Customer's credit report have not been removed
 - Customer had a minimum of 4 negative remarks on his credit report at the time of execution of this Agreement
 - Customer has not used any credit consulting agency or firm providing similar services within two years of date of this Agreement, nor has Customer attempted on his own accord to repair his credit report.

 Within five days of receipt, Customer has provided to MMI any updated credit reports and/or advised MMI if updated reports have not been received in a timely manner.

TO THE EXTENT ALLOWED BY LAW, CUSTOMER HEREBY WAIVES ANY CLAIMS AGAINST MMI, INCLUDING ANY CLAIM BASED IN TORT, NEGLIGENCE OR BREACH OF CONTRACT, THE PARTIES FURTHER AGREE THAT THE LAWS OF THE STATE OF TEXAS SHALL GOVERN THIS AGREEMENT AND THAT VENUE FOR ANY DISPUTES SHALL LIE IN THE COURTS IN HARRIS COUNTY, TEXAS.
