TREASURER REPORT: Treasurer Leila Rish gave the Treasurer's report to the Council including the Village's account balances. The water vendor received \$1,676.50. Village taxes were mailed out on July 1. To date \$10,251.33 has been received. Taxes are due in the Treasurer's office on or before September 14, 2021. Postmarks will not be accepted.

FIRE DEPARTMENT: Treasurer Leila Rish reported on the ACW-Unionville Fire Department Financial Report. The next fire board meeting is scheduled for August 5, 2021.

<u>CLERK'S REPORT:</u> The Clerk is working on the forms and other information needed to request the funding from the Michigan Department of Treasury for the American Rescue Plan Act. Submission is due by July 27, 2021. Water, sewer and trash past due notices were mailed on July 13, 2021.

<u>PARKS & RECREATION:</u> Trustee Anker received a quote for repair to the tennis courts and to convert the courts to a combination of tennis and pickleball courts. The \$25,000 quote includes all repairs, new surface, striping for two tennis courts and two pickleball courts. The council will request \$13,000 from the Columbia Township community donation program.

<u>POLICE</u>: Police Chief Bill Owens gave his monthly report to the Council. There was an extensive discussion on blight within the downtown area of the Village. The Clerk will draft a blight violation notice for the properties discussed and send via certified mail.

ZONING: The Zoning Administrator approved a zoning permit for 3089 Bay Street for a garage repair.
