<u>FIRE DEPARTMENT:</u> Treasurer Leila Rish reported on the ACW-Unionville Fire Department Financial Report. John Katnik updated the Council on the recent Fire Board meeting held on August 5. The next Fire Board meeting is scheduled for November 4, 2021.

<u>POLICE</u>: Police Chief Bill Owens gave his monthly report to the Council. Per Mr. Stecker's request, the Police Chief said he will spend more time patrolling that area, especially during the weekends where the traffic is heavier. Blight letters have been sent to the respective downtown building owners. Those owners have thirty days to remedy and eliminate their blight.

<u>DPW REPORT:</u> DPW Assistant Brent Vermeersch gave the DPW report to the Council. The storm sewer repair project on Marvin Street is completed. The Phelps Street paving project is still scheduled for this fall. Faber Masonry completed the sidewalk work on Phelps Street along with the 28' x 22' cement slab for the black dirt and brush bunker. Two trees on Brown Street in the Village right-of-way were removed by Kappen Tree Service along with some light branch trimming in the Village.
