## **NEW BUSINESS:**

- Bid Opening: Sealed bids were opened and reviewed by the Council for the repair and repainting of
  the tennis courts at the Village park. Only one bid was received. Pro Surfaces of Harrison, Michigan
  bid \$27,000 per bid specification which will include two tennis courts and two pickle ball courts. The
  work is to be completed in the summer of 2022. Motion by VanHove, second by Balzer to approve
  the bid from Pro Surfaces of Harrison, Michigan for the repair and resurfacing of the tennis courts for

**TREASURER REPORT:** Treasurer Leila Rish reported on the Village's account balances. The water vendor received \$909.00 in August. Village taxes were due on September 14 with \$110,358.34 received and \$14,366.24 delinquent.

<u>FIRE DEPARTMENT</u>: Treasurer Leila Rish reported on the ACW-Unionville Fire Department Financial Report. The next Fire Board meeting is scheduled for November 4, 2021.

**POLICE:** The Council discussed the progress of the blighted buildings downtown with two of the properties currently working to correct the issues. The Clerk will send a second notice to the remaining property owners by certified mail.

<u>DPW REPORT:</u> DPW Supervisor David Yoder presented the council with videos of Monchilov doing the patch work to the storm sewer on Phelps Street. Black dirt and grass seed was put down on alongside the new sidewalk on Phelps Street and along Marvin Street following the storm sewer work. The Phelps Street paving project is scheduled to begin this week. The controls for the sanitary sewer grinder station at the South end of the Village was replaced by B's Electric.

**ZONING:** The Zoning Administrator approved a zoning permit from the Unionville Community Association for repair to the gazebo at Kemp Memorial Park.
