<u>TREASURER REPORT:</u> Treasurer Leila Rish gave the Treasurer's report to the Council. The water vendor received \$495.25 in November. She discussed the Village's account balances and stated that she recently renewed some of the short-term CD's for a longer term because the interest rates were so low.

FIRE DEPARTMENT: The ACW-Unionville Fire Department financial report was made available to the Council. The next Fire Board meeting scheduled for February 4, 2021.

<u>POLICE:</u> Police Chief Bill Owens gave his report to the Council. The paperwork is resubmitted for CESF Grant. In order to apply for police grant assistance, the Asset Forfeiture and Use of Force Policy has been updated. The annual MCOLES certification will be completed soon.

<u>CLERK'S REPORT:</u> Senate Bill 1246 allows virtual meetings for any reason through March 30, 2021 and is awaiting the Governor's signature. Senate Bill 241, the Water Shut Off Protection Act reinstates the moratorium on water shut offs and extends the date to March 31, 2021 is also awaiting the Governor's signature. The option to offer direct deposit to all Village employees was discussed and a decision will be made at the January meeting.

<u>DPW</u>: DPW Assistant Brent Vermeersch reported that Kappen Tree Service has removed two trees and grinded ground the stumps on Cass Street at a cost of \$600. A breaker on one of the pumps at the grinder pump station off Center Street on the south end of the Village has failed. The pump needs to be manually activated approximately every two days. The Council requested that the DPW get bids together to repair or replace it. The DPW will move the ship and castle playground equipment into the DPW garage to work on some needed repairs throughout the winter.

<u>PUBLIC COMMENT:</u> Public comment was requested by President Prime, no public comment received. The Village Council and employees want to send their deepest condolences to former President Ralph Rasch's family and friends. In honor of his years of serving on the Village Council, the east pavilion at the Village Park will be named for Ralph.
