TREASURER REPORT: Treasurer Leila Rish gave the Treasurer's report to the Council including the Village's account balances. The water vendor received \$458.75 in December.

FIRE DEPARTMENT: The ACW-Unionville Fire Department financial report was made available to the Council. The next Fire Board meeting scheduled for February 4, 2021. ACW-Unionville Fire Department Chief Nick Sakon was approached by the Township of Wisner about bringing on seven additional sections over to the ACW-Unionville Fire Department. If approved this merger would reduce the assessment to be paid by the Village. This will be discussed at the February 4, 2021 ACW-Unionville Fire Board Meeting.

<u>POLICE</u>: Police Chief Bill Owens gave his report to the Council. The Village has been accepted for the CESF Grant equaling \$1122 to be used for COVID-19 related expenses. This grant will be used to help supplement the cost to implement the report writing program. **Motion** by VanHove, second by Anker to approve the Core Technology Police Reporting software as described by the invoice of \$3,660. <u>Roll Call Vote</u>: Anker-Yea, Armstead-Yea, Balzer-Nay, Katnik-Nay, Townsend-Nay, VanHove-Yea, and Prime-Yea. 4 Yeas. 3 Nays. Motion carried.

<u>CLERK'S REPORT:</u> The Clerk's office is waiting to hear from Independent Bank concerning direct deposit of Village Payroll. As there are not enough payroll checks to cover employees and council for the February 10 payroll, the Village employees will receive payroll via a payroll check next payroll and the council pay will be held until the March 10th payroll. **Motion** by VanHove, second by Townsend to delay the February 10 payroll for council meeting pay until the March 10th payroll pending information about direct deposit from Independent Bank. <u>Roll Call Vote:</u> Anker-Yea, Armstead-Yea, Balzer-Yea, Katnik-Yea, Townsend-Yea, VanHove-Yea, and Prime-Yea. 7 Yeas. Motion carried.

<u>DPW:</u> DPW Supervisor David Yoder discussed the estimate received from B's Electric to repair the grinder pump station. The estimate includes new controls, a new box and five new floats for a cost of \$6500. **Motion** by Katnik, second by Balzer to approve the \$6500 expense to have the grinder pump station south of the Village on Center Street repaired by B's Electric. <u>Roll Call Vote:</u> Anker-Yea, Armstead-Yea, Balzer-Yea, Katnik-Yea, Townsend-Yea, VanHove-Yea, and Prime-Yea. 7 Yeas. Motion carried. He also received estimates from Kemps Tiling Company for two storm sewer projects. These estimates will be used for budgetary purposes for the 2021-2022 fiscal year. The two possible projects include: Phelps Street from Granger Street to Marvin Street and Marvin Street from Phelps Street south for 620 feet. To help reduce the cost of electricity at Kemp park during Christmas, Dave is looking at the cost of converting the lights on the Christmas decorations to LED.

<u>Sanitary Sewer/Water/Storm Sewer:</u> Motion by Balzer, second by Townsend to reinstate Water, Sewer and Trash late fees beginning with the February 1st billing period. <u>Roll Call Vote:</u> Anker-Yea, Armstead-Yea, Balzer-Yea, Katnik-Yea, Townsend-Yea, VanHove-Yea, and Prime-Yea. 7 Yeas. Motion carried.
