Report was given on the L-4029 Tax Request for the tax levy rate to be sent to Tuscola County Clerk. **Motion** by D. Hartman second by B. Gaeth okayed report as presented and signed by president and clerk for mailing back to Tuscola County Clerk. 7 Yeas. 0 Nays. 0 Absent. Motion carried.

POLICE: Police Chief Bill Owens gave his report.

Report was given on 3 distinct types of tasers to council. One has a program that would train and supply the product with a warranty. **Motion** by B. Gaeth second by G.
