"Sec. 12-8. Open fires. No person shall kindle a fire in or upon any street or alley nor within 25 feet of any building, unless such fire is confined in a safe container, and in no case within 15 feet of any building. Every person who shall kindle any fire shall have some competent person constantly in charge of said fire until it is completely extinguished. (Code 1959, § 40.008)"

State law reference—Open burning of leaves and grass clippings, MCL 324.11522.

TREASURER REPORT: Treasurer Leila Rish reported on the Village's account balances. The water vendor received \$537 in October and the park's dump station brought in a total of \$907.91 for the entire calendar year of 2023.

<u>POLICE REPORT:</u> Police Chief Bill Owens gave his monthly report to the Council. He is continuing his work on the blight issues and working with the court system to take the next steps in the legal process.

<u>UNFINISHED BUSINESS:</u> As a part of last month's meeting, the council had motioned to have Jessica Riskey work on adding the property maintenance code to the Village's ordinances. She was able to provide the council with two options in doing so; amend the current ordinance or create a new ordinance. Riskey provided a list of pros to each option as well as an idea of how long the council could expect the processes to take. **Motion** by Townsend, seconded by Miracle to amend the current ordinance. 6 Yeas. 0 Nays. 1 Absent. Motion carried.

NEW BUSINESS: The council wished to revisit the committees since there were changes made during the September meeting while some members were absent. **Motion** by Balzer, seconded by Sting to approve the new committee assignments. 6 Yeas. 0 Nays. 1 Absent.
