In receipt of the Canvass of Votes Cast at the General Election held on Tuesday, November 6, 2018, Ralph Rasch having received sufficient number of votes to be elected as Village President for a two-year term ending November 19, 2020; Jeff Anker and Dave VanHove having received sufficient number of votes to be elected as Trustee for a four-year term ending November 19, 2022; Amber Schmidt and Victoria Balzer having received sufficient number of votes to be elected as Trustee for a partial two-year term ending November 19, 2020.

The Village Clerk administered the oath of office to President Rasch and Trustees Anker and Balzer. Trustee Schmidt and Trustee VanHove will be sworn in at a later date.

Motion by Trustee Balzer, second by Trustee Anker to appoint Matt Prime as President Pro-Tem to act in the absence of the Village President. 4 Yeas. Motion carried.

<u>Guests</u>: John Katnik addressed the council with a request to be appointed to the vacant trustee position. **Motion** by Trustee Balzer, second by Trustee Prime to appoint John Katnik to fill the vacant Trustee position as a partial term ending November 19, 2020. 4 Yeas. Motion carried.

Motion by Trustee Anker, second by Trustee Balzer to approve the minutes of the October 15, 2018 regular council meeting as presented. 5 Yeas. Motion carried.

TREASURER REPORT: Treasurer Leila Rish discussed the Village's CD's and account balances. The water vendor received \$531.00 for October 2018.

<u>FIRE BOARD:</u> Leila Rish gave the financial report of the ACW-Unionville Fire Department to the Council. Trustee Balzer reported on the fire board meeting. Chief Nick Sakon was reappointed for a 2-year term beginning January 1, 2019.

POLICE: The police activity report was presented by Chief Bill Owens. Chief Owens is continuing to work with the Village Attorney on the demolition of the elevator.

<u>DPW REPORT</u>: DPW Supervisor Yoder gave his report to the Council. Four of the six lights at the park have been shut off to help reduce electric cost in the park during the winter. Water lines at the park were winterized. The lagoons were inspected by the state with a satisfactory result. It was requested that the Council look into replacing the plow/dump truck.

<u>UTILITIES</u>: The Clerk presented the utility usage report to the Council.

<u>PARKS</u>: Trustee Anker presented quotes received from Sinclair Recreation, LLC on options for playground equipment. Following discussion, a new piece of playground equipment will be purchased from Sinclair Recreation, LLC for \$15,572.96. The Council would like to thank the Unionville Community Association for their gracious donations to the Village parks.
