Motion by VanHove, second by Katnik to approve the minutes of the September 16, 2019 regular council meeting with two changes: (1) **Motion** by VanHove, second by Katnik to waive the 10% Special Event fee during the 2019 softball tournament for the Unionville Volunteer Fire Department and to refund their fee of \$214. (2) Due to a calculation error, September budget adjustments to add up to \$865 instead of \$680. 6 Yeas. Motion carried.

GUESTS:

- Don Duggar came to the council meeting again and introduced self to those that were not at the last meeting. He also talked a little more about the grant writing process.
- Phillip Serey, who lives just north of the Village on Zimmerman Road, questioned the
 council on how to get faster internet to his home. The council suggested fiber optic
 through Air Advantage and Mr. Serey was given the company's contact number. Mr.
 Serey also inquired about the possibility of having sanitary sewer installed to his home.
 Because the property is outside of the village, the council responded that it would not be
 feasible to install sanitary sewer that distance.

TREASURER REPORT: Treasurer Leila Rish gave the final report for the summer taxes with \$113,054.21 being collected and \$10,305.76 delinquent. The Village account balances and CD's were discussed. \$667.25 was received from the water vendor.

FIRE DEPARTMENT: Leila Rish gave the financial report of the ACW-Unionville Fire Department to the council. The Unionville Volunteer Fire Department will be hosting their Fall Benefit Breakfast on Sunday, November 3 at the Gateway Sportsman Club. Proceeds will go to the purchase of ice rescue equipment. The next Fireboard meeting will be November 6, 2019.

<u>POLICE:</u> Police Chief Owens gave his report to the council. The homecoming parade and tailgate party went very well. **Motion** by Prime, second by Katnik to send a blight letter to the property owner of 3001, 3009 and 3021 Bay Street. The letter will be attached as permanent record. 6 Yeas. Motion carried.

<u>DPW REPORT:</u> The fire hydrant at the far west end of Church Street has been replaced by Kemps. Because of the replacement, forty homes needed to be shut off and boil-advisory was issued for those homes. The last day for brush removal by the DPW is November 1. The park bathrooms have been updated and are winterized until spring. Miller Seal came and sealed the park path.
