TREASURER REPORT: Treasurer Leila Rish reported on the Village account balances. The water vendor received \$252.25 in December.

<u>FIRE DEPARTMENT:</u> Leila Rish gave the financial report of the ACW-Unionville Fire Department to the council. The next Fire Board meeting is scheduled for February 6, 2020 at 7 pm in the Village Board Room.

POLICE: The Police Report was made available to the Council.

<u>DPW REPORT:</u> The DPW went to Shults Equipment in Ithaca to see the new dump truck. The upfitting of the new dump truck is expected to be completed this week and should be ready for pick up next week. Following last month's storm sewer problems on Marvin Street, Dave Yoder recommends new 12 inch storm sewer pipe running 480 feet from 3159 Phelps Street to 3076 Phelps Street with catch basins at each end of the new pipe. The Council will consider this recommendation when preparing the 2020-2021 budget. The lights will remain on in the park as long as there is not too much snow and the park path is usable.
