## 2020 EXHIBITOR RULES & REGULATIONS

1. Booth sizes are: Expo Floor Booth 6' x 6', Outside Booth based on square footage usage
2. **Please provide full payment when application is submitted.**
3. **The PVCC office must receive applications and payment by June 19th.**
4. All exhibitors must provide their own extension cords. **All extension cords must be taped down.**
5. You must have prior Chamber approval to sublet or share your booth. Exhibitors found subletting or sharing their booths without prior Chamber approval will be closed.
6. No more than 2 people behind each table in your booth(s). Children that require adult supervision are NOT allowed in booth(s).
7. Any exhibitors of firearms or animals must occupy outdoor booths with the exception of service animals.
8. PVCC reserves the right to rearrange booths to better accommodate all exhibitors. PVCC will make every effort to place exhibitors in requested spaces.
9. PVCC reserves the right to refuse any application where it is in the best interest of PVCC and accepted exhibitors.
10. Exhibitors must keep their immediate areas clean throughout the event and you must clean the area at the conclusion of the event.
11. Nothing may be hung on the walls within the Pahrump Nugget.
12. Any checks returned for insufficient funds will be charged a \$30.00 service fee. All service fees must be paid in full by money order or cashier's check prior to exhibiting. Failure to make payment will result in forfeiture of booth space. You will not be a member in good standing until the service fee is paid.
13. Exhibitors may set up booths on Thursday, June 25th, from 12pm to 4pm or Friday, June 26th, from 8am to 11am. Booths and Exhibitors are required to be ready one (1) hour prior to opening each day.
14. All booths must be staffed by an organization representative for the duration of the Expo. No booths are to be left unattended. Please start the tear down process at 3:10 pm on Saturday.
15. The Pahrump Valley Chamber of Commerce nor the Pahrump Nugget is responsible for exhibitor merchandise, their property, vehicles and any damage incurred to merchandise.
16. PVCC reserves the right to have signage found to be offensive removed. PVCC has the right to terminate any exhibitor.
