II. TREASURERS REPORT

- \$2135 in prepaid monthly assessments
- Expenses for March
- March was negative (\$2715) to budget on operating expenses
- Receivables were \$1108 by the end of Mar with no concerns
- General Repair and Maintenance was high due to a \$2400 repair on the gate.
- Landscaping was high due to \$5700 to remove trees and trim the dunes.
- YTD we are negative (\$534) to budget on expenses.

III. OLD BUSINESS

- <u>Landscaping</u> Jonnie reported that Ty from The Greenery will replace the
 plants that did not live. The bamboo will be cut in May. The pine straw is
 not down yet and they will put Lantana in all of the pool pots, as it needs
 little care.
- Bath Fans Are turned off

- <u>Gates</u> Jack reported that the beach gate is sticking open and he will tighten the spring hinge. Jack said the street pedestrian gate seems to be working fine with a new spring hinge. It was recommended to have a sign made for the gate that says: "Please pull gate closed"
- <u>Janitorial Issues</u> Rosanne asked Craig to contact the company and have them step up their cleaning procedures. They will be cleaning 3x per week in the summer.
- Annual Meeting The meeting notice was sent out to all owners.
- <u>Dehumidifier</u> Unit 2H has requested having their dehumidifier drain put in to the chaise on the balcony. Jack is going to reach out to Craig and suggest to the owners that they use Gray's HVAC to have the drain line installed. Jack is following up on this issue

IV. NEW BUSINESS

- <u>Summons</u> Rosanne had to sign the summons from the town to allow the
 easement to create a new bike path on our side of South Forest Beach
 Drive. We will be compensated \$1,600 for our 3 feet. We can use it to redo the landscaping near the sign.
- Hall Secretary Lisa Maulding has sold her unit and is no longer on the board. Rosanne will take minutes until a new secretary is voted in.
- Loose walkway boards Rosanne reported that they have been repaired.
- Hallway Floors They will be power washed on May 18th
- <u>Foot Bath Signage</u> There needs to be a sign near the foot shower to "clean off sand before entering the pool"
