Rental Assistance Available for Many Families Impacted by Evictions

The social and economic turmoil created by Covid-19 has impacted many Minnesota families, whether due to illness and medical bills, job layoffs, business closures, on-and-off school and childcare closures, relationship pressures, and many other stressful circumstances. Thankfully, some families who have gotten behind on rent due Covid-19 impacts have been protected from eviction by executive order issued by the governor in March 2020. These eviction protections are ending as of October 12, 2021. But families behind on rent and utility bills can still avoid eviction if they take advantage of rental assistance available through RentHelpMN.org or by dialing 211. To be eligible for help with rent and utility bills, families need to have household income below 80% of the median income in their area. Most families in rental housing in the Twin Cities meet this requirement. There is no need to wait for an eviction notice. Families who are behind on rent or utility bills should apply now. Until June 1, 2022, eligible families whose applications for rental assistance are pending are protected from eviction. Families faced with an eviction notice or other serious issues with rental housing such as lockouts or repair problems should seek legal help right away.

For Ramsey County residents, SMRLS may be contacted 9am - Noon and 12:30pm - 3 pm, Monday thru Friday at 651-222-4731. Persons with housing problems related to domestic violence may call the Minnesota Domestic Violence Crisis Line at 866-223-1111.
