



## Tuition Agreement

START DATE: August 19th 2025

School hours of operation: 8:45 a.m. to 2:45p.m. Monday-Thursday.

The School will be closed on breaks and holidays following Austin ISD. All tuition payments will be due should the school close due to severe weather conditions or other reasons beyond the school's control.

- A non-refundable annual registration fee of \$500 is payable upon the signing of this Enrollment Agreement.
- The first tuition payment of \$ 1575 (lower) 1675 (upper) is due July 1, and 9 subsequent monthly payments due the 1st day of the month with the last payment occurring on April 1.
- Tuition in full may be paid on July 1 or before the first day of school
- A materials fee of \$300 is due every year at the time of enrollment.
- A late fee of \$100 will be added if your child's tuition is not paid by the close of business on the fifth day of the month.
- A late pick up fee of \$35 will be added to your child's tuition charges if your child is not picked up by 2:45 with an additional \$1 per minute(s) after 3:15 pm.
- A service charge of \$100 will be added to tuition charges for returned payment or insufficient funds.
- Should tuition payments and other fees not be paid as agreed upon herein, enrollment will be terminated.
- You must provide written notice 30 days prior to your child's last day of attendance. Failure to provide the required notice will result in additional tuition obligations for the notice period.

The Ammonite School may terminate this Agreement at any time upon 30 days written notice. The Ammonite School reserves the right to terminate the enrollment of any child who is unable to adjust to the School's program. Please note that we will do everything possible to make accommodations for your child. The Ammonite School is inclusive and if a child needs support beyond our capability with staffing, we would request the family bring in an aide to support them, before changing enrollment status.



The parents/guardians whose names appear on the first page of this Agreement acknowledge and agree that they shall be liable for any and all costs incurred by The Ammonite School arising from or relating to the collection of Tuition, Late Fees and/or Service Charges which are not paid as specified in this Agreement, including any and all attorneys fees and court costs. The Ammonite School also has the right to collect interest, charged at the legal rate, for all outstanding balances.

Annually, The Ammonite School may institute increases in Tuition and/or other fees..

All parents/guardians agree that should their child(ren) be the subject of an executed, court approved custody, separation or other form of legally enforceable agreement determining the custodial status of such child(ren), they shall provide copies of all such agreements to The Ammonite School and shall provide to any and all changes, amendments and updates to such agreements in a timely manner.

No one other than the owner of the school, may change, alter or modify this Agreement or the policies of the school. All school policy changes will be made in writing and two weeks notice will be provided for all written modifications, by which the undersigned parents/guardians agree to abide.

The parties have read and understand this tuition agreement and signatures constitute the entire agreement between the signees and The Ammonite School.
