In addition to competing in multiple interscholastic competitions, Hofstra hosted two interscholastic competitions this semester. In its inaugural year, the First Chair trial competition, which was co-hosted by Hofstra, the University of San Diego School of Law, and the UCLA School of Law, hosted 14 teams at the New York location. In its seventh year, the National Medical-Legal Trial Competition hosted 16 teams, with Hofstra Law alumni, the Honorable Juan Merchan, serving as the presiding judge for the tournament's final round.

This year's intramural competition was one of the largest in recent years, with over 85 law students competing, many of whom participated in mock trial for the first time. This year's final round was presided over by Hofstra University alumni Judge Steven Tiscione of the Eastern District of New York. The round featured three 1L advocates and one 2L advocate, with the team of Rachel Coleman and James Wilson defeating Joe Maiorano and Daniella Diaz. Daniella Diaz (1L) won Best Oral Advocate.
