#### **CASE SUMMARY**

People of the State of Hofstra v. Austin Droz a/k/a "Droz"

This is a criminal case where the defendant, Austin Droz, ("Droz") is charged with one count of burglary in the third degree under Hofstra Penal Law § 140.20, and one count of larceny under Hofstra Penal Law § 155.05. Droz is a Canadian rapper, singer, and songwriter. He got his start acting on a hit teen drama television show. Today, he is one of the most streamed and best-selling artists in the world, credited with shaping modern hip-hop and popularizing emotional vulnerability in rap. Jay Shaffer, better known as "Lil Shafe", is an American rapper, songwriter, and record producer known for his sharp lyricism, storytelling, and social commentary. He is widely considered one of the greatest rappers of all time, praised for his lyrical depth, conceptual albums, and cultural impact. For years, Droz and Lil Shafe worked closely together.

On February 5, 2025, Droz celebrated his birthday with a lavish party attended by some of the most influential names in the industry, including the global country music icon Rachel Heyman and pop powerhouse James Axis. Lil Shafe, slighted by not receiving an invitation, responded with a diss track titled "Uninvited" where he said "You needed ten features to fill the room. Still couldn't drop a hit without auto-tune." In retaliation, Droz released a song of his own, titled "No Apologies" where he fired back by saying "You're watching my party from your parent's couch. Mad 'cause they cheer my name when yours is drowned out." In this song, Droz rapped about how he would do anything for fame.

Following this incident, the rift between the two rappers continued to grow as negotiations for a joint tour collapsed. The tour had been scheduled for a while, but Droz's desire to include an up-and-coming new rapper in the tour led to a vicious feud that shredded whatever friendship the two had left, leading to multiple diss tracks being released, and ignition of both fanbases. Lil Shafe's superfans so passionately agreed with him that they would riot around Droz's concerts, hotels, and even home. Before the Grammys, Lil Shafe released a final diss track titled "*Not One of Us*".

On June 16, 2025, the Grammy Awards, one of the most prestigious music award shows, took place in Hempstead Hills. That night, Lil Shafe earned a career-defining win when he won the coveted trophy for Best Rap Album. Droz, who had been nominated in the same category,

left the show empty-handed. Tensions between the two were already high, and Lil Shafe's victory only deepened the rivalry between the rappers and their fans.

In preparation for the Grammys, Droz's team booked the Rosenblatt Suites for him and his staff on the 8th floor of the Barron Hotel located in Hempstead Hills, because of the hotel's luxury. By coincidence, Lil Shafe's team booked suites in the same hotel, but on the 7th floor.

The evening of the Grammys, there were watch parties for all different types of fans at neighboring bars. A large group of Lil Shafe fans filled with excitement were kicked out of Maddie's, a popular bar in Hempstead Hills, causing fans to fill the streets and approach the Barron Hotel. The hotel lobby descended into chaos as fans swarmed in after the show. Fans were chanting, blasting *Not One of Us*, and drinking to celebrate. After the show, Lil Shafe even joined his fans in the lobby, encouraging the celebration. The fans loved seeing him, flooding the room with a strobe of flashing lights from their pictures.

When Droz's car arrived at the hotel, seeing the crowd of Lil Shafe fans caused Droz to grow increasingly frustrated by Lil Shafe's Grammy win and the public praise that followed. Inside the hotel, Lil Shafe stood celebrating and rallying amongst his fans. Droz's security brought him into the building through an employee only entrance to avoid adding to the riot. Fueled by pride and unresolved tension, Droz told his team he was going to "set the record straight."

Ryan Polisi is Droz's longtime public relations manager and a key architect of his public image. He has been recognized at the highest levels of the industry, earning a top spot on *PRWeek*'s prestigious Power List alongside renowned names like Tree Paine and CeCe (Cassey Coleman). For the past decade, he has coached Droz through media training and managed every aspect of his public narrative with remarkable precision. The ongoing feud with Lil Shafe stands out as one of the few major challenges Droz has faced during his tenure with Polisi.

Ryan Polisi warned him that escalating the feud could backfire. Instead, Polisi advised him to take the high road and end the feud. If Droz did, Ryan reasoned, not only would Droz appear mature in the public eye, but he would also unlock new opportunities to profit from the situation. Leaving his hotel room, Droz made his way to Lil Shafe's suite, passing a Lil Shafe fan in the hallway. This fan, Jo Wilson, later recalled that Droz looked nervous and was mumbling to himself.

When Droz arrived at the door, a single knock caused it to swing open. Housekeeping later confirmed that they were tidying up from Lil Shafe's Grammy celebration, clearing away champagne and confetti, but got distracted by the chaos in the lobby and left quickly without locking the door. One thing had been left untouched by housekeeping and any other person in the room: a banner sprawled across the wall that read, "He's not even top 2." A clear jab at Droz's iconic lyric: "I know I said top five, but I'm top two and I'm not two" from his hit song "No Apologies."

Later that night, Lil Shafe discovered his Grammy was missing and filed a police report. Lil Shafe told the police that he saw Droz leave the hotel with the Grammy peaking out of Droz's "No-V-O" branded backpack. Law enforcement then tracked Droz's cell phone to find Droz at the Cerri Hotel, located on Weiss Street, one of the most popular streets in town. When law enforcement searched the surrounding area, the Grammy was discovered in a trashcan on Weiss Street. At 7:05 AM on June 17, 2025, Droz was arrested in the city of Hempstead Hills, Deane County, State of Hofstra.

#### RULES OF THE COMPETITION/PRETRIAL ORDER

#### A. Time Limits

Each team, prosecution and defense, has a total of 35 minutes within which to: (i) present its opening statement; (ii) present direct testimony of its two witnesses; (iii) cross-examine the two witnesses presented by the opposing side; (iv) read into the record any relevant stipulations, including convictions; and (v) give its closing argument.

Each team is allowed five minutes to present and argue no more than two pre-trial motions. The five minutes will not count against the team's total of 35 minutes. The clock will stop for arguments of objections. It is within the discretion of the presiding judge to allow or deny lengthy arguments. If a team appears to be making frivolous objections or extended argument in an attempt to run the clock against its opponent, judges may take this into account when scoring and may award additional time to an aggrieved team. A team need not use all its allocated time. No rebuttal case is permitted.

# **B.** Scope of Examinations

It is left to the discretion of the presiding judge to determine the scope of cross examination pursuant to Federal Rule of Evidence 611. The scope of cross-examination should not be strictly limited to the matters to which the witness testified in direct if it would curtail impeachment or other reasonable inquiry. The re-direct examination cannot go beyond the scope of cross-examination, assuming the cross-examiner makes an appropriate objection. Re-cross is not allowed unless the party seeking re-cross contends that the witness has invented one or more material fact(s) on re-direct examination. In that event, the party should ask the judge for leave to re-cross for the purpose of impeachment. Re-cross must be strictly limited to impeaching the witness about the alleged invented fact(s). The presiding judge will make the initial determination as to whether re-cross is permitted. All scoring evaluators will independently determine whether, based upon the impeachment, the fact is invented and/or material. Each evaluator will then independently determine what, if any, score adjustments ought to be made based upon the gravity of the rule violation, if any (this includes potential deduction from the advocate who invoked the re-cross procedure if the evaluator deems the challenge to be meritless). All scoring evaluators will be instructed consistent with this rule.

# C. Objections

Objections during the direct and cross-examination of a witness must be made and argued only by the advocate who is responsible for the direct or cross-examination of the particular witness. Objections during the other side's opening statement and closing argument must be made only by the advocate who is responsible for handling his or her team's opening or closing. This rule does not prohibit advocates from the same team from conferring with each other regarding any matter during the course of trial. The defendant may confer with the advocates during the trial. As a matter of courtesy, counsel should request permission to approach the bench for side-bar conferences with the judge, although sidebars will be constructive so that the scoring members in the jury box may hear the arguments of counsel.

#### D. Order of Trial

The presiding judge and the scoring evaluators will enter the room. All parties are allowed to move about the well, must ask to approach witnesses on cross examination, but not on direct examination, and must ask permission to have a constructive side-bar. Next, the presiding judge will entertain motions in limine, if any. Opening statements will then be presented: prosecution, then defense. The prosecution will present its case in chief first, then the defense. There is no rebuttal case for the prosecution. After both sides have rested, each side will present closing arguments. The order of closing argument is: defense, then prosecution. After the scoring ballots and comments are finished, the students will get brief feedback from the evaluators.

#### E. Presiding Judge to Rule on Motions in Limine & Objections

- 1. During the course of the trial, motion and objection arguments are matters exclusively decided by the presiding judge. At the judge's discretion, the clock will be stopped for such matters, but please keep in mind that the competition is on a tight schedule and trials cannot be permitted to exceed the designated time frames. The presiding judge shall cut off the competitors' arguments if appropriate.
- 2. The current Federal Rules of Evidence, the Federal Rules of Criminal Procedure, and the U.S. Constitution apply.
- 3. Each side may present no more than two pre-trial motions in limine and has five minutes to argue such motions. These motions may be in writing, but they may not be any longer than one page, double-spaced, exclusive of caption and signature.

4. Given the time constraints, outside case law may not be used in arguing motions or objections.

# F. Witnesses

The witnesses shall testify, as best as possible, in a manner consistent with the trial materials. Witnesses may be impeached by omission. If a witness makes a statement inconsistent with a statement the witness has signed, the witness must admit that the document in the case file is authentic, that he or she read the statement before signing it, and that the signature belongs to the witness. If a statement is a "sworn" statement, the witness must admit to making such a statement under oath. The witness must admit, if questioned, to fabricating a statement of material fact that is not in the file. Where the trial materials are inconsistent, the witness must make a choice as to which scenario to follow. In some instances, this choice will expose the witness to the possibility of being impeached. Otherwise, the witness is free to make reasonable assumptions about the background and personality of the character the witness is portraying. A witness may not invent facts not provided in the fact pattern. Nor, while testifying, may a witness invent an individual not mentioned in this problem and have testimony or evidence offered to the court or jury from that invented individual.

#### G. Exhibits

Competitors should assume that the exhibits in the file are reasonably accurate and fair representations of the matters they purport to represent. If asked, the witnesses must admit that the photographs, maps, and/or diagrams of the locale are fair and accurate representations of that which they purport to represent. There is no requirement that the teams use every exhibit, and no adverse inference may be drawn from a failure to use every exhibit.

#### E. Case Summary Guidelines

The "Case Summary" on pages 5-7 is not evidence and may not be introduced or referenced for any purpose, including but not limited to refreshing the recollection of or impeaching a witness.

#### SUBSTANTIVE STIPULATIONS

The parties have stipulated to the following facts and points of law. These stipulations may be raised in support of legal arguments, and stipulated facts may be read into the record at each side's discretion, with permission of the Court:

- 1. This is a closed universe fact pattern. All motions in limine and objections shall be limited to the Federal Rules of Evidence.
- 2. All exhibits in the file are fair and accurate representations of the matters they purport to represent. All exhibits included within the problem are what the proponents claim them to be for the purposes of authentication, and the Court will not exclude any exhibit on the basis that it has not been properly authenticated.
- 3. All physical evidence, statements, and identifications were constitutionally obtained. No party may object to the admission of evidence at trial on those grounds. Arguments regarding the constitutionality of evidence collection are not permitted.
- 4. Austin Droz, a/k/a "Droz" was arrested at 7:05 A.M. on June 17, 2025 by Detective Jenny Roberts at the Cerri Hotel. The backpack depicted in Exhibit 11 was recovered from his person at the time of his arrest. All that the backpack contained at the time was: 1 cell phone, phone number 416-308-2308; 1 black t-shirt; 1 pair of men's jeans; 1 pair of men's socks; 2 gold necklaces. Droz's Gold Toucan statue, pictured in Exhibit 14, was not found in the backpack at the time of his arrest, and has not been recovered by police prior to trial. Pursuant to this Court's pretrial rulings, arguments regarding the constitutionality of this arrest are not permitted.
- 5. Exhibit 16 is a cell phone location report that indicates where a given cell phone was located at a given time. The parties agree that this exhibit tracks the cell phone that Droz had on him at the time of his arrest, and that the times and locations indicated are accurate. Pursuant to this Court's pretrial rulings, arguments regarding the constitutionality of the tracking of Droz's cell phone are not permitted.
- 6. All signatures that appear on any document are genuine and all documents are originals unless otherwise stated.
- 7. Parties may not bring any additional evidence for the trial. Any demonstrative exhibits, other than enlargements of the materials in the file, must be created during the trial. All

- demonstrative exhibits created during trial are subject to the Federal Rules of Evidence. Parties may not raise the argument that the opposing party has failed to call a particular witness or witnesses to testify at trial. However, arguments about investigative steps not taken are permitted.
- 8. All photographs are fair and accurate representations of the people or things depicted therein.
- 9. The parties agree that "@Devoted2LilShafe.4.ever." is an X account belonging to Jo Wilson. Exhibit 1 is a post from that account posted on June 1, 2020. The screenshot of Jo Wilson's X post was obtained by Detective Roberts in furtherance of the investigation and preparation for trial.
- 10. Exhibit 9 is the receipt referenced by Lil Shafe in his grand jury testimony. Lil Shafe signed the receipt. The parties agree that Exhibit 9 is a business record under FRE 803(6), and any objections to this exhibit on the basis of hearsay or hearsay-within-hearsay have been waived.
- 11. Exhibit 12 is a photograph taken by Detective Jenny Roberts on June 17, 2025 at 6:37AM. The picture shows Lil Shafe's Grammy in a garbage can directly outside of the Cerri Hotel on Weiss Street.
- 12. The parties agree that Exhibit 13 is a fair and accurate representation of the text messages sent from Droz's phone to Lil Shafe on June 16, 2025 at 11:04 P.M. The screenshot was taken by Detective Roberts at a later date than when the text was sent.
- 13. All recoverable security camera footage from the Barron Hotel on the night of June 16, 2025 is contained in this record. This evidence was obtained by Detective Jenny Roberts.
- 14. Detective Jenny Roberts has been deemed by the Court as unavailable to testify at trial and the case will move forward without her testimony.

#### **RELEVANT STATUTES/LAWS**

# Hofstra Penal Law § 140.20: Burglary in the third degree.

A person is guilty of burglary in the third degree when he knowingly enters or remains unlawfully in a dwelling, with intent to commit a crime therein.

# Hofstra Penal Law § 140.20(a)(1): Definitions, Dwelling.

"Dwelling" means a building or structure, or any portion thereof, that is regularly used by a person for overnight lodging, regardless of whether a person is actually present at the time of the offense. This includes any house, apartment, hotel, motel, mobile home, or trailer, whether permanent or temporary in character.

# Hofstra Penal Law § 155.05 : Larceny.

A person commits larceny when, with intent to deprive another of property or to appropriate the same to himself or to a third person, he wrongfully takes, obtains, or withholds such property from an owner thereof.

- 19 me. But he's just a poser, a pretender to the throne. Droz
- 20 wants to take the crown off my head, but he's so far below
- 21 me, he can't even reach my feet.
- 22 Q: Mr. Shaffer, again, please stay focused on my
- 23 questions and avoid making personal comments.
- 24 A: Alright then.

- 1 Q: How long have you known Droz?
- 2 A: For years now. When I started in the rap game, he
- 3 helped me in some ways boost my profile, took me on tour
- 4 with him, things like that. My career took off faster than
- 5 most, partly thanks to that kind of stuff.
- 6 Q: How would you describe your relationship with Droz
- 7 now?
- 8 A: Terrible. We've been drifting apart over the last
- 9 few years, but we got into some beef earlier this year that
- 10 really shredded whatever friendship we had left.
- 11 Q: What happened that tore you two apart?
- 12 A: A few things went down. We got pretty competitive
- 13 with each other, trying to prove who was the best, and that
- 14 takes a toll on any friendship. In February, he hosted this
- 15 ridiculous party for his birthday in Toronto. He had all
- 16 these famous singers and celebs there, but didn't invite
- 17 me. I was kinda upset, so I threw some jabs at him in some
- of my songs. He did the same back, but nothing too bad. The
- 19 real beef between us was ignited by the tour.
- 20 **Q:** What tour was that?
- 21 **A:** We had a joint world tour scheduled for a while.
- 22 Despite the recent incidents and fading friendship, we
- 23 wanted to keep a good working relationship, so the tour
- 24 was still going forward. Our label, Rift Records, wanted

- 1 to add this new artist called \$elina \$ullivan to the tour
- 2 because they were trying to launch her career.
- 3 Q: Did you want her to come on tour with you?
- 4 A: I really did not. Droz did though, and that's what
- 5 drove us the current beef we got now.
- 6 Q: Where did that lead to?
- 7 A: It led to our current state Droz and I hate each
- 8 other now. We got into arguments the last few times we saw
- 9 each other in person. We started releasing diss tracks
- 10 about each other after that.
- 11 **Q:** What do you mean by diss track?
- 12 A: It's a song with lyrics that attack or insult other
- 13 people, usually other singers or rappers, in this case me
- 14 and Droz taking shots at each other. The diss track in our
- 15 beef got really heated and specific, and the wedge between
- 16 us got bigger and bigger.
- 17 **Q:** What was the name of your diss track?
- 18 A: It's called "Not One of Us."
- 19 **Q:** How did your fans deal with this beef?
- 20 A: We both got pretty big fanbases, and fans on both
- 21 sides can be pretty serious and intense, so our beef only
- 22 intensified that. As tensions rose, our fans got involved
- in ways that we did not see coming.
- 24 **Q:** In what ways?

- 1 A: There's been incidents of riots and violence
- 2 between our fans, a lot of which made it on to the internet
- 3 and sometimes the news. It's actually become pretty bad,
- 4 and it felt personal.
- 5 Q: Was there a riot the night of the Grammys, June 16,
- 6 2025?
- 7 **A:** I wouldn't call it a riot, it was a party.
- 8 **Q:** What happened that night?
- 9 A: It started with the Grammy Awards. Droz and I
- 10 were both up for Best Rap Album, which of course, I won.
- 11 This was my crowning moment. I feel like it really
- 12 solidified me as the Greatest of All Time and all that
- 13 stuff that I was saying earlier. Droz left empty handed.
- 14 Q: How did the fans react to this?
- 15 A: They freaked out, on both sides. I saw some fights
- 16 and then a riot broke out on the street outside the
- 17 building, it was madness. I left the theater after the
- 18 show was over with my security detail, but some of the
- 19 craziness followed us back to the hotel.
- 20 **Q:** Did they attack or threaten you?
- 21 A: No. At this point it was mostly my fans, they just
- 22 wanted to party with me. A lot of them kept chanting, "Not
- one of us! Not one of us!"
- Q: Once you were in the hotel, what did you do?

- 1 A: At first, I was upstairs partying with my crew in
- the suite, but when we heard the fans were downstairs, I
- 3 wanted to join them to celebrate.
- 4 Q: What did you do next?
- 5 A: I called the front desk to request housekeeping to
- 6 come clean. We had made a mess in the suite.
- 7 Q: Did housekeeping come and clean your suite?
- 8 A: I think so. The front desk said that they would
- 9 take care of it. And I saw some people with cleaning
- 10 supplies on my floor as I headed to the lobby.
- 11 Q: Let's talk about that. Did you make it to the
- 12 lobby?
- 13 A: Yes. I met up with my fans to celebrate.
- Q: While you were in the lobby, where was your Grammy
- 15 award?
- 16 A: I left it in my hotel suite. I didn't want to risk
- 17 losing it in the crowd that was in the lobby, so I left it
- 18 on the table in the suite. I put it right next to the
- 19 champagne and ice bucket.
- 20 Q: Did you see Droz in the hotel at any point that
- 21 night?
- 22 A: Yeah! I found out later that he was staying in the
- 23 same hotel as me, one floor up. When I was partying with
- 24 the fans, I was standing up on a little platform talking

- 1 with a microphone, and I was able to see him walk by in the
- 2 back with his crew.
- 3 Q: Was there anything you noticed about him?
- 4 A: Yes, he looked really upset and I saw something
- 5 gold and shiny sticking out of that toucan designer
- 6 backpack that he was wearing. It looked like a Grammy. They
- 7 have a distinct shape, like a record player's horn. At the
- 8 time, I thought he had bought fake Grammys as party favors
- 9 to give out or brought his old trophies because he was so
- 10 sure he would win, but when I saw my Grammy was gone, I
- 11 realized it had to be my real Grammy. I didn't know it at
- 12 the time, but he was just trying to rub it in my face.
- 13 **Q:** What happened next?
- 13 A: He turned and saw me looking at him. He stopped for
- 15 a second and just stared at me. Right after that, he
- 16 smirked and held up his middle finger to me, and started
- 17 walking real fast, and left through the front door of the
- 18 hotel lobby.
- 19 Q: I'm showing you what's been marked as Exhibit 11,
- 20 do you recognize it?
- 21 **A:** Yes.
- 22 **Q:** What is it?
- 23 A: That's the designer backpack I saw Droz carrying
- 24 that night.

- 1 Q: How do you recognize it?
- 2 A: It has that dumb toucan on it.
- 3 Q: Is it a fair and accurate depiction of the backpack
- 4 you saw him carrying on the night of June 16, 2025?
- 5 **A:** Yes.
- 6 MR STOEHRER: Members of the grand jury, I'm now
- 7 showing you EXHIBIT 10.
- 8 Q: How far away would you say you were from Droz when
- 9 when you saw him?
- 10 A: I'd say about 50 feet, maybe.
- 11 Q: Do you know if anyone else in the crowd saw him?
- 12 A: Nah. They were all focused on me and what I was
- 13 saying. My fans were in a rabid state. If they saw Droz,
- 14 they would've turned around and gone after him and his
- 15 crew.
- 16 **Q:** Were you drinking at all that night?
- 17 **A:** Of course man! They gave us drinks in the theater
- during the show and then we were partying all night in the
- 19 hotel, so I had more than a few.
- 20 **Q:** How much did you have to drink that evening?
- 21 A: I can't say for certain. We were all drinking. I'd
- 22 have to look at the receipt I got from the hotel.
- Q: When you say "we", who are you referring to?
- A: My crew. I was traveling with some friends, my

- 1 manager, and bodyguard. They all stayed in my suite.
- 2 Q: How many people in total were staying in that suite
- 3 with you?
- 4 A: 5 people in total.
- 5 Q: Did they all go downstairs with you to the lobby?
- 6 **A:** Yes.
- 7 **Q:** Did they have their own access to the room?
- 8 A: Yes, they had their own room cards.
- 9 Q: Did you give anyone else access to your room that
- 10 night?
- 11 A: No. Just whoever the hotel sent to clean my suite.
- 12 **Q:** When did you first realize that the Grammy was
- 13 gone?
- 14 A: When I went back up to my suite after the party.
- 15 Q: Let's talk about that. When you got up to your
- 16 suite, did it look like it had been cleaned?
- 17 **A:** Yes. I just saw some confetti and two glasses of
- 18 champagne. Everything else had been cleaned up. But my
- 19 Grammy was gone.
- 20 Q: You claimed earlier Droz took it. Why do you say
- 21 that?
- A: He's jealous of me! Droz knew that this Grammy
- 23 meant that I was the GOAT, and he just couldn't handle the
- 24 fact that I beat him!

- 2 BY MR. MAIORANO
- 3 Q: Good afternoon, please state your name for the
- 4 record.
- 5 A: Hello, my name is Jo Wilson.
- 6 **Q:** How old are you?
- 7 A: I am 26 years old.
- 8 Q: Where do you live?
- 9 A: In the city of Hempstead Hills in the State of
- 10 Hofstra. I've lived here my whole life.
- 11 **Q:** What is your occupation?
- 12 A: I work as a professional golf ball diver.
- 13 **Q:** Um... what is a golf ball diver?
- 14 A: You know at the golf courses when the balls fly
- into the water I go dive and retrieve them. It is
- 16 exhilarating.
- 17 Q: Oh. Are you familiar with Lil Shafe?
- A: Of course, he's the greatest!
- 19 **Q:** How do you know him?
- 20 A: Well, I don't really know him personally. I hadn't
- 21 met him until just recently. I've been a fan for many
- 22 years. He's my favorite musician and the greatest rapper of
- 23 all time! So I guess I know him the way you know any
- 24 celebrity I read about him on the internet, see videos

- of him on YouTube or the news, see interviews on TV or
- online, and of course listen to his music.
- 3 Q: What about Droz? Are you familiar with him?
- 4 **A:** Unfortunately.
- 5 Q: What do you mean by that?
- A: I know who he is, but I hate him. He's the worst!
- 7 **Q:** Why is he the worst?
- 8 A: He's a liar, and a poser! He thinks he's the GOAT
- 9 but we all know it's Lil Shafe!
- 10 Q: What do you mean by "GOAT"?
- 11 A: It's short for Greatest of All Time. It's a title
- 12 that rightfully belongs to Lil Shafe, but Droz always tries
- 13 to claim it for himself.
- 14 Q: Do you know Droz personally?
- 15 A: No, same as with Lil Shafe I met him briefly at
- 16 the hotel he was staying at the night of the Grammy party.
- 17 **Q:** What do you mean by Grammy party?
- 18 A: There was a party in a hotel the night that
- 19 Lil Shafe won the Grammy for Best Rap Album of the Year,
- 20 which officially crowned him as the GOAT!
- 21 **Q:** When was this party?
- 22 A: June 16, 2025, right after the Grammys show.
- 23 **Q:** Where was it, specifically?
- 24 A: In the lobby of the Barron Hotel in Hempstead

- 1 Hills, Hofstra.
- 2 Q: How did you end up at that party?
- 3 A: I live in the city where the Grammy Awards were
- 4 being hosted. There was a watch party with a group of Lil
- 5 Shafe fans at a bar next to the theater called Maddie's.
- 6 Lil Shafe won his award at the end of the show, and we all
- 7 freaked out. It was amazing! The whole crowd started
- 8 jumping and cheering. After a few minutes, I guess it was
- 9 too much for the bar owner, so we got kicked out. We
- 10 poured into the street outside the theater, still
- 11 celebrating.
- 12 **Q:** Did you run into any Droz fans once outside?
- 13 A: I didn't see any. Later I heard that there had been
- 14 clashes between Lil Shafe fans and groups of loser Droz
- 15 fans, but that was after I left.
- 16 **Q:** Why did you leave?
- 17 A: Right after I got outside Maddie's and into the
- 18 street, I heard someone say that Lil Shafe was staying at
- 19 the Barron Hotel, so a chunk of the crowd started to head
- 20 that way, and I followed hoping we could keep the party
- 21 going and maybe meet Lil Shafe!
- 22 Q: Did you end up meeting Lil Shafe?
- 23 A: Not directly, but I got to see him up close he
- 24 heard about the crowd and came down to party with us! He

- spoke to the whole crowd, so I got to see him from like 50
- 2 feet away! It was so cool!
- 3 Q: Did you leave the party at any point?
- A: Yeah, I was pretty hungry. The Barron has a
- 5 restaurant on the 15<sup>th</sup> floor called Ruben Sto's Steakhouse.
- I went up there to get food. I thought the wait wouldn't be
- 7 long because the party was still going on in the lobby.
- 8 Q: Was Lil Shafe still at the party when you left?
- 9 A: Yes! I figured that I would go grab a steak and
- 10 come back down, hoping that the victory party was still
- 11 going on. Lil Shafe looked like he was ready to go all
- 12 night and celebrate with his fans. What a guy.
- 13 **Q:** How long were you gone?
- 14 A: Around 15 minutes.
- 15 **Q:** What happened up there?
- 16 **A:** I made it up to the 15<sup>th</sup> floor only to find Ruben
- 17 Sto's had closed already, so I started heading back down.
- 18 I got in the elevator to go back to the ground floor where
- 19 the party was, but the elevator stopped on floor 8 on the
- 20 way down. When the doors opened, I was shocked to see Droz
- 21 walk by!
- 22 **Q:** Did he get in the elevator?
- A: No, he didn't.
- Q: Did you notice him looking at you at any point?

- 1 A: No, he didn't even look towards the elevator.
- 2 Q: Describe his appearance as he walked by.
- 3 **A:** He was wearing a blue suit and had his stupid
- 4 designer toucan backpack on. He had both fists clenched,
- 5 like he was going to punch somebody.
- 6 Q: What happened after he passed you?
- 7 A: When I saw Droz pass the elevator, I stuck my head
- 8 out to see where he was going. He was walking down the hall
- 9 toward the staircase down at the other end. Then, I saw him
- 10 enter the stairwell, where he went down the stairs to the
- 11 7<sup>th</sup> floor where Lil Shafe's suite was.
- 12 MR. MAIORANO: That last sentence is stricken from the
- 13 record. Members of the grand jury, you must disregard the
- 14 witness's statement about where the defendant went once
- 15 he entered the stairwell.
- 16 Q: Mr. Wilson, you didn't actually see Droz on the 7<sup>th</sup>
- 17 floor, correct?
- 18 A: That's right. I saw him go into the stairwell and
- 19 that was it.
- 20 Q: Did you hear Droz say anything when you were on the
- 21 8<sup>th</sup> floor with him?
- 22 A: I sure did. When he passed me, he was muttering
- 23 angrily under his breath.
- Q: Could you tell what he was saying?

- 1 A: For sure. He said "I'll show him... thinks he's
- better than me? It belongs to me! I'm the GOAT."
- 3 **Q:** Did he say who or what he was referring to?
- 4 A: Not explicitly, but c'mon! Droz was talking
- 5 about Lil Shafe! He went right down those stairs and stole
- 6 it from Lil Shafe's room!
- 7 MR. MAIORANO: That testimony is stricken from the
- 8 record. Members of the grand jury, you are to disregard

1	Police Interview of <u>Austin Droz A/K/A "Droz"</u> by Detective Jenny Roberts
2	HEMPSTEAD HILLS POLICE DEPARTMENT
3	
4	Q: Hello, I am Detective Jenny Roberts. Please state your name for the record.
5	A: Austin Droz, but internationally known as Droz.
6	Q: What is your occupation?
7	A: Seriously? I'm the boy. The 516God. I make music. I rap, sing, produce, and
8	write. But I never lost touch with my sensitive side.
9	Q: Tell me about some of your accomplishments in your career.
10	A: Sure. I have had top singles since '09. I just released "6AM in Uniondale."
11	I've released multiple platinum albums, had over a dozen songs hit number one on the
12	Billboard charts, sold out world tours, and collaborated with some of the biggest names in
13	the industry. I am one of the legends.
14	<b>Q:</b> Are you involved in any other businesses?
15	A: Yeah. I embrace my own personal brand. I've used it to build a substantial
16	portfolio of companies outside of music. I have a fashion line that makes apparel and
17	accessories. We collaborate with other designer brands as well.
18	Q: What's it called?
19	A: "No-V-O." It's short for "Nassau's Very Own." We brand all of our items with
20	this dope Toucan logo. The people love it, man.
21	Q: Do you wear any of your own stuff?
22	A: Oh yeah. It's very high quality. Of course.
23	O: I'm showing you what has been marked as Exhibit 11. Do you recognize this?

1	A: Sure do! That's my backpack, one of my favorite collabs - between LV and
2	No-V-O. It's actually the only one ever produced. Custom made for yours truly.
3	Q: I'm showing you what has been marked as Exhibit 14. Do you recognize this?
4	A: Yes, that looks like security footage of me walking from the Barron to the
5	Cerri Hotel.
6	Q: What is sticking outside of your backpack?
7	A: That must be my lucky toucan. After I made LV a song for their runway
8	shows, they made me the backpack and this toucan trophy. Ever since, I usually keep the
9	toucan in the backpack—it goes almost everywhere with it.
10	Q: I'm showing you what has been marked as Exhibit 13. Do you recognize this?
11	A: Yes, exactly that is my lucky LV toucan.
12	Q: Have you ever won a Grammy?
13	A: Yes, I've won for some of my singles - "Fulton Street Flows," "516man," and
14	"10 PM on Hempstead Turnpike." But I never won a Grammy for Best Rap Album.
15	Q: Are there a lot of conflicts in the music industry?
16	A: Yes, plenty. Sometimes it is fake for publicity or just speculation by the press,
17	but other times it's real.
18	Q: Do you have a conflict with Lil Shafe?
19	A: Sort of. It was a little issue that started off as real, but whenever either of us
20	would mention it, we got so much publicity that we both continued. It was like an
21	unspoken agreement we had going to make things super dramatic.
22	Q: Is it fair to say this was "good for business"?
23	A: Yeah, it was helping us both. It definitely piqued the interest of our respective

1 fanbases. 2 **Q:** How long have you known Lil Shafe? 3 **A:** I have known him for years now. We used to work with the same people, then 4 took him under my wing. I basically started him. 5 **Q:** Were you in the State of Hofstra on June 16, 2025? 6 **A:** Yes, I was there for the Grammy Awards in Hempstead Hills. 7 **Q:** Were you nominated for any awards? A: Yeah, I was nominated for Best Rap Album, but I didn't win. Lil Shafe did. 8 9 **Q:** How did you feel about that outcome? 10 A: Disappointed, sure, but it's the Grammys. It happens. I wasn't mad, just 11 exhausted. My plan was to lay low that night. I wasn't in the mood to go to any 12 after parties. 13 **Q:** Where were you staying that evening? 14 **A:** At the Barron Hotel. My team and I were staying in the Rosenblatt Suites 15 there, the best rooms in the building. **Q:** Were you aware that Lil Shafe was also staying at the Barron Hotel? 16 17 **A:** Not until after the show. I found out he was staying on the floor below me. 18 **Q:** What happened after you returned to the hotel that evening? 19 A: The lobby was packed with fans shouting, cameras flashing, music echoing, 20 and people crowding every corner. Security had to sneak me in through the employee 21 entrance to avoid the chaos. I was tense and just wanted to sleep. 22 **Q:** Did you speak to anyone about how you were feeling? 23 A: Not really. I just talked to Ryan. Told him the whole night was a mess, the

1 fans were wild, and I was sick of the drama. 2 **Q:** Who is Ryan? 3 A: Ryan Polisi? He is my public relations manager. He is the best. He sets up 4 interviews, runs my social media, and steps up when drama hits. Basically, he makes 5 sure I stay in the spotlight for the right reasons. He and I have been working together 6 for over ten years, so we are super close, and I tell him everything. 7 **Q:** What did you say to him that night? A: I think I told him how mad I was and that I was going to go to Lil Shafe's 8 9 suite to talk it out. I texted Lil Shafe before to see if he could meet up. 10 Q: I'm showing you what's been marked as Exhibit 13, do you recognize it? 11 A: Yeah, that's a text from my phone to Lil Shafe. It never got delivered, so we 12 didn't talk things out. 13 **Q:** What do you mean by talk things out? 14 A: Ryan suggested that I go to Lil Shafe's suite and congratulate him to calm 15 things down. 16 **Q:** Why did Ryan suggest that? 17 A: He said it'd be better for my image. Honestly, I knew it was good for publicity 18 that either Lil Shafe or I won. If the other nominees, like Rachel Heyman or James Axis 19 won, I would have been happy for them, but Lil Shafe winning gives me more attention 20 so I agreed with Ryan that congratulations were due. I didn't feel like we had a real issue, 21 just something fans dragged out. 22 **Q:** Did you go down to Lil Shafe's suite? 23 A: Yes, I did.

1	Q: While you were walking there did you pass anyone?
2	A: No, I don't remember passing by anyone.
3	Q: I'm showing you what's been marked as Exhibit 4, a still shot from the
4	Barron Hotel's security system. What's going on here?
5	A: Oh yeah, I pressed the button for the elevator. When it opened, that guy was
6	inside and he was wearing a Lil Shafe T-shirt, so I knew he had to be a crazy fan. I
7	would never trap myself in an elevator with a psycho like that, never without my security.
8	Q: Then what happened?
9	A: I walked right past the elevator and to the stairs.
10	Q: When you got to the suite, was the door to the suite locked?
11	A: No, I gave one gentle knock and it just swung open.
12	Q: The door was unlocked when you arrived?
13	A: Yeah. At that point I assumed it was unlocked because Lil Shafe was in there.
14	Q: Was Lil Shafe in the suite?
15	A: No, but about three other people were. It's a big suite so I don't know how
16	many for sure. Between working with similar people and having a past with Lil Shafe, I
17	know almost everyone he works with, and whoever was in the suite were not a part of his
18	team.
19	<b>Q:</b> Who were they?
20	A: I still don't know, definitely not hotel staff. They flinched and scattered when I
21	walked in, and not in a way that shocked fans or even haters do, like they were up to
22	something.
23	Q: What did these people look like?

1 **A:** I can't really say for sure. It all happened so fast. 2 **Q:** Could you see what they were doing when you walked in? 3 A: No. **Q:** Did you see where they went after they "scattered"? 4 5 **A:** No. I'm pretty sure the room had another exit. 6 **Q:** What else did you see when you entered the suite? 7 A: My room was so much nicer, this was a normal suite, but it looked like it had been trashed, I couldn't tell for sure. 8 9 **Q:** Why do you say it looked like it was trashed? 10 A: It was messy, bro. 11 **Q:** Was there anything that stood out to you in the room? 12 A: Yes, there was a banner dissing my lyrics. The banner had to have been made 13 before the Grammys. Lil Shafe's team was so confident that he would win, as if I didn't 14 have just as good of a chance. It's ironic since Lil Shafe is always saying to be humble 15 and there was nothing humble about this. 16 **Q:** Was there a Grammy in the room? 17 **A:** I can't say for certain, I didn't see it anywhere. 18 **Q:** Then what happened? 19 A: I left the hotel, I didn't feel safe staying there anymore, so I left and went to 20 the nearby Cerri Hotel. 21 **Q:** You didn't feel safe? 22 A: Things were getting too crazy for me. I just saw those strange people in Lil 23 Shafe's room. A bunch of his fans were rioting in the lobby. It was time for me to leave.

1 **Q**: Did you leave with your backpack? 2 A: Yeah, I left with it on. 3 **Q:** Did you leave with the Grammy? A: No man, I didn't take it. To be honest, that hotel was like a mob scene. People 4 5 partying all over the place, drunk, chanting "Not One of Us", rioting. Lil Shafe's door 6 was unlocked when I got there. Anyone could have walked in and taken it! Worst of all, 7 no one from Lil Shafe's team seemed to be watching over it. Seems like he took winning the Grammy for granted. 8 9 **Q:** Well, what was in your backpack? 10 A: Some jewelry, a change of clothes, and my other phone because you never 11 know when that hotline is gonna bling. 12 **Q:** Why did you go to the room? 13 A: I told you! I only went to the suite to end a feud. I know what it looks like, but 14 I have respect for the award and I think it should be earned, not taken. 15 **Q:** Did you know that Lil Shafe wasn't in the suite? 16 **A:** No, I went to the suite to talk to him, obviously thought he was in there. 17 **Q:** I'm showing you Exhibit 12. What is this? 18 A: That's a Grammy, and it's in a garbage can. 19 **Q:** Do you recognize the location? 20 **A:** No idea where that is. 21 **Q:** This picture was taken on Weiss Street. It's directly outside of the Cerri Hotel. 22 You don't know how it got there? 23 **A:** I don't know how many times I have to tell you! I have no idea.

4	Q: Good afternoon, please state your name for the record.
5	A: Hi, my name is Ryan Polisi.
6	Q: Where do you live?
7	A: I live in Hempstead Hills in Hofstra, but I've moved around
8	following Droz.
9	Q: What is your occupation?
10	A: I am a public relations manager. I run publicity and image consulting for high
11	profile clients in the music industry.
12	Q: How long have you worked in this field?
13	A: About fifteen years. It only took me 5 years to become the best of the best. The
14	past ten years I have worked exclusively with Droz.
15	Q: What are your responsibilities as Droz's publicist?
16	A: I handle media strategy, press releases, crisis communications, interviews, red
17	carpet prep. Basically everything that helps shape how the public sees him. Throughout
18	the years we have become close, we advise each other especially when tensions run
19	high.
20	<b>Q:</b> Is your reputation tied to your client's reputation?
21	A: My job is to make my clients look good. When they shine, it reflects well on
22	me. If they look bad, I look like I don't know how to do my job. That said, not every
23	client gives me much to work with. In that case, I do what I can, but I won't take the fall

1 for choices they make. Some clients understand that, others don't. 2 **Q:** Have you ever heard of Jo Wilson? 3 **A:** No, is he famous? Who is that? 4 **Q:** He is also known for his social media username @Devoted2LilShafe.4.ever. 5 I'm showing you what's been marked as Exhibit 1, do you recognize it? 6 A: Of course I do, I could never forget that username! He has left hate comments 7 on Droz's posts for about 8 years now. His name always stood out to me because he hated 8 Droz before anyone ever hated Droz, including Lil Shafe. I've seen him post some 9 creepy stuff. 10 **Q:** What posts are you referring to? 11 A: Years ago he posted something weird, like "Droz, I can't wait for your 12 downfall". Recently, he posted "Lil Shafe I would do anything for you, 13 aannyytthhiinngg". I have blocked him on Droz's account so many times, but he must be 14 some type of tech freak, because he always figures out how to undo it! 15 Q: Were you with Droz on the evening of June 16, 2025, after the Grammy 16 Awards? 17 A: Yes, I was. 18 **Q:** Can you walk us through what you observed that night? 19 **A:** We left the show after Droz lost, I left in the same car as him and he seemed 20 fine. Then, when we got to the hotel, we saw Droz fans and Lil Shafe fans filling the 21 lobby. Then, I saw what was either Lil Shafe or a damn good impersonator rallying his 22 fans in the lobby, so I made sure security dropped us off at the employees entrance so we 23 could we could get in without causing a scene. Once inside, Droz told me he was a little

1	bothered.
2	Q: What did you two talk about?
3	A: He was irritated, and in the heat of the moment he said he wanted to "talk it
4	out with Lil Shafe". I advised him that he should only talk it out to smooth things over. I
5	told him to take the high road, that in the end he would benefit off of it.
6	Q: What did you mean by that?
7	A: That he should squash the drama, congratulate Lil Shafe, spin the whole loss in
8	a positive light. If he did that, he'd look like the bigger person and gain more long-term
9	goodwill. You know the brand deals, media buzz, that sort of thing.
10	Q: Did Droz have Lil Shafe's number to reach out to him?
11	A: Yeah, they used to work together, so he definitely had his number. But I meant
12	more of a public congratulations on social media, since that would get him attention.
13	Q: How did Droz respond to that advice?
14	A: He cooled down. He agreed and said something like "I guess you're right" and
15	that he'd say something supportive. At that point, I genuinely thought that was his plan.
16	Q: Did you see Droz later on that night?
17	<b>A:</b> No.
18	Q: Did you ever tell Droz to go to Lil Shafe's suite?
19	A: No. I suggested he make a gesture, again, I was thinking of making a post or
20	something subtle. I didn't suggest going to his suite directly. That was his call.
21	Q: Did Droz ever say he was going to take anything from the suite?
22	A: Absolutely not. That's not who he is. He might have been angry, but he was
23	talking like someone who wanted to de-escalate the situation.

1	Q: What do you make of what happened next?		
2	A: I don't know what went through his head in that suite. But what I do know is		
3	that Droz had every reason to keep this situation under control, he had too much to lose		
4	by making things worse. Droz's walk up to Lil Shafe's suite was nothing more than an		
5	attempt to make amends. But now, Droz is the victim of baseless accusations of stealing		
6	Lil Shafe's Grammy. It doesn't make sense to me.		
7	<b>Q:</b> Is it common for Droz to go for a walk without his security team?		
8	A: It has happened before, but it's not common.		
9	<b>Q:</b> Do you think he went into that suite intending to steal the Grammy?		
10	A: No, absolutely not. I know him better than anyone. He's honest, he values hard		
11	work, and he believes in earning awards, not taking them. He never even hated Lil Shafe,		
12	it was all for show. From everything we talked about and the mood that night, I'm		
13	certain stealing was never on his mind.		
14	Q: Is it fair to say that you're close with Droz?		
15	A: Very. He's not just a client to me, he's a brother. I always look out for him and		
16	he does the same for me. We stay close together in No-V-O. We've been through highs		
17	and lows together, and I know exactly how he handles pressure.











Barron Hotel Lobby Floor Plan




Hotel Floor 7 Plan






