WAIVER AND RELEASE OF LIABILITY EXPRESS ASSUMPTION OF RISK:

ASSUMPTION OF RISK: I, the undersigned, am aware that there are significant risks involved in all aspects of yoga, exercise and physical training. I am aware that any of these risks may result in serious injury or death to myself. I fully acknowledge I am willing to participate in personal training and exercise with knowledge of these risks. Further, I willingly assume full responsibility for the risks that I am exposing myself to and accept full responsibility for any injury or death that may result from participation in any activity or exercise while at, or under the instruction of, Unity Human Performance LLC or Unity Yoga Center, LLC (collectively, "Unity") and any of Unity's coaches, principals, agents, employees, owners, volunteers, sub-lessees, or contractors.
