Receiver filed a reply 20 clarifying that the petition Petition "merely seeks to secure Court approval of proposed procedures 21 for the sales of real property out of receivership; it does not request Court approval of any 22 specific sale." ECF No. 218 at 2 (emphasis added). No other Defendants filed an opposition to the 23 Petition. 24 Having reviewed the moving papers, it appears the concerns set forth in Humphries 25 opposition (ECF NO. 212) are most as the Receiver is merely seeking permission to establish the 26 procedures for the sale of real property, but is not seeking approval to sell any real property at this 27 time. Accordingly, having come before this Court and good cause appearing, this Court
