1 IT IS HEREBY STIPULATED by and among the parties hereto, Plaintiff Securities and  
 2 Exchange Commission (“Plaintiff”), Geoff Winkler, Receiver for J&J Consulting Services, Inc.  
 3 (“Receiver”) and Kamille Dean (“Dean”), by and through their respective counsel of record, that  
 4 Dean may have two (2) additional days to file and serve her reply to the Receiver’s *Omnibus*  
 5 *Response to: 1) Non Party Kamille Dean’s Motion to Quash Jurisdiction Over Kamille Dean and*
