ECF Nos. 409, 410. No response to these Motions was filed. This Order pertains only 14 to the Motion to Strike or Leave to File Reply. This Order makes no findings of fact and issues no 15 conclusions of law with respect to Ms. Dean's Objections.² 16 Receiver's Motion seeks to strike provisions of Ms. Dean's Opposition to Receiver's Memorandum of Fees. ECF No. 409 at 4-6. On December 29, 2022, the Court issued an Order 17 18 granting Receiver attorneys' fees arising from his successful Motion to Compel after considering 19 only those portions of Ms. Dean's Opposition germane to the award of fees. ECF No. 417. For this 20 reason, Receiver's Motion to Strike or, Alternatively, for Leave to File a Reply is moot. 21 Accordingly, IT IS HEREBY ORDERED that Receiver's Motion to Strike Portions of 22 Kamille Dean's "Opposition" to the Receiver's Memorandum of Fees and Costs and Declaration in 23 24 25 Receiver's filings at ECF Nos. 409 and 410 are identical. Only ECF No. 409 is cited herein. 26

Ms. Dean filed an Objection at ECF No. 380 that objects to the Court's Order at ECF No 368. Ms. Dean also

In any event, neither ECF No. 380 nor ECF No. 396 is ruled upon in this Order.
