2 Kircher Rickard (the “Applications”); and the Court having found that notice was proper and
3 that good cause exists to approve the same,

4 **IT IS HEREBY ORDERED, ADJUDGED AND DECREED THAT** the Omnibus
5 Motion to Approve Third Quarterly Applications for Fees and Reimbursement of Expenses for
6 Receiver and Receiver’s Counsel for the Period from October 1, 2022 through December 31,
7 2022 is hereby GRANTED and:

- 8 (1) the Receiver fees of \$381,121.50 and costs of \$17,099.18 are allowed;
- 9 (2) Greenberg Traurig fees of \$195,809.57 and costs of \$2,089.93 are allowed;
- 10 (3) Allen Matkins fees of \$265,656.50 and costs of \$4,625.94 are allowed; and
- 11 (4) Semenza Kircher fees of \$7,672.50 and costs of \$629.46 are allowed.

12 The Receiver is hereby authorized to pay 80% of the allowed fees and 100% of the
13 allowed costs from funds on hand in the receivership estate.
