STIPULATION AND ORDER FOR NON-PARTY KAMILLE DEAN'S PAYMENT OF FEES AND COSTS

Court appointed receiver Geoff Winkler ("Receiver") by and through his counsel of
record, the law firm of Greenberg Traurig, LLP and non-party Kamille Dean hereby stipulate as
follows:

On August 1, 2022, the Receiver filed a Motion to Compel or Alternative Motion
 for Order to Show Cause Why Kamille Dean Should Not be held in Contempt for Failure to
 Comply with This Court's Order (the "Motion to Compel"). ECF No. 210.

2. On November 17, 2022 the Court entered an Order granting the Receiver's
Motion to Compel. ECF No. 368. In granting the Receiver's Motion to Compel, the Court
awarded the Receiver the attorneys' fees and costs associated with bringing and succeeding on
the Motion to Compel. *Id.*

8 3. On December 1, 2022, the Receiver submitted his Memorandum of Fees and
9 Costs relating to the Motion to Compel. ECF No. 378.

10 4. On December 29, 2022, the Court entered an Order granting the Receiver's
11 Memorandum of Fees and Costs in the amount of \$33,755.24 (the "Motion to Compel Fee
12 Award"). ECF No. 417.

13 5. On January 12, 2023, Ms. Dean filed an Objection, Request for De Novo Review,
14 and Appeal from Magistrate's 12-29-22 Order (the "Objection").

6. On March 1, 2023, the Court entered an Order Affirming Magistrate Judge's
Orders, denying Ms. Dean's Objection and granting the Receiver's request for additional
attorneys' fees incurred in responding to Ms. Dean's objections. ECF No. 473.

7. On March 10, 2023, the Receiver submitted his Memorandum of Fees and Costs
relating to his response to Ms. Dean's Objection seeking fees in the amount of \$32,803.61 (the
"Second Fee Memorandum"). ECF No. 481.

8. As of the date of this stipulation, the Court has not yet ruled on the Receivers
Second Fee Memorandum. However, Ms. Dean is willing to stipulate to the amount due and the
payment schedule set forth below.

24 9. Through the Motion to Compel Fee award and the Objection Fee Memorandum,
25 Ms. Dean is to pay the Receiver \$66,558.85.

26 10. As of the date of this stipulation, Ms. Dean has paid the receiver ten thousand
27 dollars (\$10,000.00).

WHEREAS, the Receiver and Ms. Dean have reached an agreement to facilitate
 Ms. Dean's payment of the outstanding amounts due under the Motion to Compel Fee Award
 and the Second Fee Memorandum, totaling fifty-six thousand five hundred fifty-eight dollars
 and eighty five cents (\$56,558.85) (the "Outstanding Balance"). The terms of the Receiver and
 Ms. Dean's agreement are as follows:

6 1. Ms. Dean will pay the remaining \$23,755.24 due pursuant to the Order entered
7 on the Motion to Compel Fee Award by March 31, 2023.

8 2. Ms. Dean will stipulate to paying the Receiver the \$32,803.61 requested in the
9 "Second Fee Memorandum" by making six (6) equal monthly installments as set forth in the
10 payment schedule below (the "Payment Schedule").

and/or vacate the pending Second Memorandum of Fees (ECF No. 481).

5. The Receiver and Ms. Dean stipulate and agree, in the event Ms. Dean violates
the terms of this Stipulation, the Receiver shall re-new his memorandum of fees to include any
additional fees incurred through collection efforts and the drafting of any and all necessary
correspondence and/or filings before this Court including, but not limited to, the drafting of any
