12 The court-appointed Receiver, Geoff Winkler, submitted his Ninth Status Report on  
13 July 31, 2024. ECF No. 690. The court held a hearing on the report and related application<sup>1</sup>,  
14 motions, and related filings (ECF Nos. 690, 693, 694, 695, 696, 697)<sup>2</sup> on September 16, 2024. *See*  
15 Mins. of proceedings, ECF No. 704. The court finds that notice was proper for all pending  
16 motions, and there were no objections or oppositions to any of the motions or applications,  
17 either before or during the hearing. *Id.*

18 Accordingly, having considered the application, together with the additional information  
19 proffered during the September 16, 2024 hearing, and there being no objection thereto, I find  
20 good cause to accept and approve the Ninth Status Report (ECF No. 690) in its entirety and to  
21 grant the Receiver's application for fees and costs (ECF No. 697). Accordingly:

22 IT IS HEREBY ORDERED that the omnibus Ninth Quarterly Status Report and the  
23 actions of Receiver Geoff Winkler [ECF No. 690] is accepted and approved in its entirety.

1 IT IS FURTHER ORDERED that the motions to approve the ninth quarterly  
2 applications for fees and reimbursement for expenses for the Receiver, Receiver's Counsel, and  
3 Receiver's Professionals for April 1, 2024, through June 30, 2024, [ECF Nos. 693, 696, 697] are  
4 approved and granted in their entirety.

5 IT IS FURTHER ORDERED that the Receiver is authorized to continue administering  
6 the receivership entities and their estate in accordance with the terms of the Order Appointing  
7 Receiver, to undertake the recommendations presented in the Ninth Status Report, including  
8 continued engagement of professionals he deems necessary for the proper administration of the  
9 receivership entities and their estate, and to provide any other relief the court deems necessary  
10 and appropriate to fulfill his duties.

11 IT IS FURTHER ORDERED that the following fees and costs are approved:

12 (1) Receiver fees in the amount of \$749,438.00 and costs in the amount of \$3,362.76;

13 (2) Greenberg Traurig fees in the amount of \$66,609.59 and costs in the amount of  
14 \$469.27;

15 (3) Baker Tilly fees in the amount of \$19,199.00 and costs in the amount of \$110.71;

16 (4) Aitheras fees in the amount of \$10,466.00;

17 (5) Allen Matkins fees in the amount of \$109,861.33 and costs in the amount of \$3,480.88;

18 and

19 (6) Semenza Kircher fees in the amount of \$765.50.

20 The Receiver is hereby authorized to pay eighty percent of the allowed fees and one  
21 hundred percent of the allowed costs incurred by the Receiver, Greenberg Traurig, Allen  
22 Matkins, and Semenza Kircher from funds on hand in the receivership estate. The Receiver is  
23 further authorized to pay one hundred percent of the allowed fees incurred by Baker Tilly and  
24 Aitheras from funds on hand in the receivership estate.

1 IT IS FURTHER ORDERED that the receivership should continue under the terms set  
2 forth in the Order Appointing Receiver [ECF No. 88].
