1. Rent Payment:

The Lessee shall pay a monthly rent of Rs. **7,500/-**, payable on or before the **5th** day of each month without fail.

2. Maintenance & Vacant Possession:

The Lessee shall maintain the premises in good condition and return it in the same state on termination or after giving one month's notice. Similarly, the Lessor may also issue one month's notice for vacating.

3. Subletting & Usage:

The Lessee shall not sublet the premises and shall only use it for **residential purposes** for providing boarding facilities to staff.

If the Lessee continues to occupy the premises after expiry or termination, rent shall be payable for the extended stay.
