Consideration

1. 2. The Participant understands that the Participant would not be permitted to participate in the activity described below unless the Participant signed this Waiver.

- 8. The Participant has been given the opportunity and has been encouraged to seek independent legal advice prior to signing this Waiver.
- 9. This Waiver contains the entire agreement between the parties to this Waiver and the terms of this Waiver are contractual and not a mere recital.
