# 1.2 May 26, 2022 Operations and Engineering Committee Meeting Summary

The summary from the May 26, 2022 Operations and Engineering Committee meeting was presented and was unanimously accepted without change.

## 1.2 Overview of Los Vaqueros Dam Design and Cost Estimate

Marguerite Patil, Interim Administrator, introduced Stan Ali, Senior Engineer at Contra Costa Water District (CCWD), who provided the Committee with a PowerPoint presentation that gave an overview of the design of the proposed changes to the Los Vaqueros Dam and presented the current draft cost estimate for such project-related work as well as next steps in design. The current construction cost estimate is \$253 million (2021 dollars), which is lower than prior estimates due to refinements made during the design phase. An updated cost model is in development.

Members of the Committee posed questions on certain items discussed in the presentation. Ms. Patil and Mr. Ali provided further clarification, including with respect to the involvement of the California Department of Water Resources, Division of Safety of Dams in the review and oversight of the Project during both the design and construction phases. Chris Hentz, Los Vaqueros Reservoir Expansion Project Engineering Manager at CCWD, addressed the risk assessment issue. He stated that based on prior work done on expanding the dam, most of the risks have already been identified and mitigated. He further stated the primary risk at this point is the potential for construction cost increases.

#### **Future Agenda Items:**

Ms. Patil asked members of the Committee for input regarding future items to be discussed. Committee members suggested a presentation that could provide more detailed information on underlying projects that are in progress and a presentation on South Bay Aqueduct in connection with the Phase 2 Los Vaqueros Reservoir Expansion Project.

It was the consensus of the Committee to cancel	the July meeting and	to schedule the next meeting
in August.

The Authority is required to execute CAPBs with the California Department of Water Resources and the California Department of Fish and Wildlife prior to the Final Award Hearing for the Phase 2 Los Vaqueros Reservoir Expansion Project. CAPBs establish the requirements and procedures for the administration of the public benefits funded by the WSIP.

# Water Storage Investment Program Overview



- Total amount of state funding awarded by the California Water Commission (CWC) is based on the public benefits that were recognized in the Maximum Conditional Eligibility Determination
  - Proposition 1 established the allowable categories of public benefits
    - At least 50% of the public benefits were required to be ecosystem benefits
  - The CWC's regulations for their Water Storage Investment Program (WSIP regulations) established the requirements for the quantification of public benefits and long-term management of public benefits







# **Ecosystem**

- Increased water supply for San Joaquin Valley wildlife refuges
- Improved survival of salmonids migrating through Delta

# **Emergency Response**

- Catastrophic emergency
- Drought emergency

# Recreation

 Enhance recreation at Los Vaqueros Reservoir & Watershed






# Water Storage Investment Program (WSIP) Requirements








- ✓ Feasibility studies and final environmental documentation
- Funding agreement between the JPA and its Members to ensure project is fully funded (Service Agreement)
- All federal, state, and local approvals, certifications and agreements required
- California Department of Fish and Wildlife (CDFW) and California
  Department of Water Resources (DWR) make individual findings that
  public benefits meet all the requirements of Water Code 79750 et seq.
- JPA executes contracts for administration of public benefits (CAPBs) with CDFW and DWR
- CWC holds a public hearing allowing for public review and comment (CWC Final Award Hearing) and determines all requirements have been met



# **Contracts for Administration of Public Benefits**






- Adaptive management plan
- Description of public benefits
- Reporting requirements (to CDFW, DWR and CWC)
- Assurances regarding how the project will be operated, maintained, repaired, replaced and rehabilitated
- Allowance for CDFW and DWR inspection during project construction and operation
- Actions the administering agency may take if project fails to comply with contractual responsibilities
- Other provisions deemed necessary by CDFW and DWR













- CAPBs are anticipated to establish the required duration of the public benefits
  - WSIP regulations do not include a specific requirement for duration



 CAPBs are anticipated to consider long-term average of public benefits as well as inter-annual variability







WSIP regulations require adaptive management plans include:

- Public benefit monitoring metrics
- Monitoring locations, frequencies, and timing
- Metric evaluation methodology and trigger levels that initiate adaptive management actions
  - Based on best available science
- Decision making process, including the administering agency role, and the adaptive management actions that would be taken when a trigger is reached
- Funding sources and financial commitments to implement the adaptive management plan
- Other items deemed necessary on a case-by-case basis by administering agencies

# Contract for Administration of Ecosystem Benefit





- verifying the public ecosystem benefits
- administration of public ecosystem benefits
- CDFW has provided a first draft of contract for administration of ecosystem benefit
  - Appears to closely track the WSIP regulations
- CDFW has reviewed permit applications & operations modeling to confirm ecosystem benefits
- CDFW is requiring issuance of their incidental take permits prior to execution of CAPB
- CDFW is in the process of developing adaptive management plan framework





# Contract for Administration of Emergency Response and Recreation Benefits



- DWR is responsible for:
  - verifying the public emergency response and recreation benefits
  - administration of public emergency response and recreation benefits
- DWR has initially indicated they prefer a combined CAPB (emergency response and recreation)
- DWR has assigned staff, but has not yet provided a draft of the contract or adaptive management framework



# **Next Steps for CAPBs**

- Continue to work with CDFW to advance permitting
- Work with CDFW to complete development of CAPB and adaptive management plan for ecosystem benefits
- Work with DWR to develop CAPB and adaptive management plan for emergency response and recreation benefits
- Work with CWC to determine additional reporting requirements, if any, and prep for Final Award Hearing
- Continue to coordinate with other WSIP project proponents on approach to CAPB development
