Happy New Year! I hope that everyone enjoyed a happy and healthy holiday season.

Here is a list of resolutions for Branch 14 as we enter the new year.

1. Remain diligent in protecting the rights of letter carriers. This will always be the most crucial job of the branch. As we enter the new year here at Branch 14, many of the same issues we faced in 2025 will likely carry over. If you face a problem or believe you have a grievance, you must contact your steward in writing. If there is no steward at your office, contact the hall at 502-964-3200. We will continue to make a union presence known at each of our stations and associate offices. Last year, we missed Springfield and Eminence, so we hope to visit them very soon.
2. Find ways to get more participation with the union. This starts with attending union meetings. We consistently have between 50 and 60 members at a meeting. It would be great if we had over 100 at every meeting. I will even pledge that if we have 100 members at a meeting in 2026, I will do the Polar Plunge next year. We have also passed a by-law change that will allow members to attend meetings online. We are working on the details of when and how this happens.

We are also seeking additional ways to reach you. In addition to the newsletter, the webpage, and social media (Branch 14 on Facebook), we are considering a private

website that only members can access, with the approval of a webmaster, and a possible quick survey to represent you better.

3. Step up participation in the Letter Carrier Political Fund (LCPF). We are currently less than 10 percent and need to double that. The game of politics is not fun or clean, but as a federal agency, we must participate. LCPF only allows letter carriers and their families to donate. Due to the Hatch Act, we are not allowed to discuss the fund on the workroom floor or while in uniform. The Postal Service faces a litany of challenges in Congress annually. LCPF helps establish a bulwark against those challenges. In the latest 2024 congress, the last time data was released, LCPF supported both parties because it supports candidates who support Letter Carriers.

Some of the ideas we are considering include raffles for members who donate to the LCPF at union meetings, using volunteer donations (attendance not mandatory), and hosting our great LCPF organizer, Matt Tanner, at an event to discuss the importance of the fund and how to join—having a phone bank to call members to discuss, and using directed mailings. No amount is too small to help the cause.

4. Increase our donations to the Muscular Dystrophy Association. In the last two years, we have raised over \$40,000 for the NALC's primary charity. That is great, but I think we can do much more. We already have a series of events throughout the year, including a bowl-a-thon, 50/50 raffles at each union meeting, Super Bowl Squares, golf scrambles, and other events. In 2026, we hope to add a trivia night that I will host and write all the questions, with a date to be determined. The branch is open to all ideas. Does the station with the most

donations win a prize? (To be based upon a percentage of members plus giving, it would be unfair for Annshire and Lagrange to count equally.

5. Promote unionism both in and outside of work. At work, again, be vigilant of your rights, but also of your brothers and your sisters. When we stand side by side and shoulder to shoulder, we are much more challenging to defeat. Also, take a more active role in our Letter Carrier Food Drive, which is an excellent opportunity to help your community.

Outside of work, attend union events. Last year, we had a karaoke night, a Trunk-or-Treat, and a Holiday Christmas Party. We always need volunteers for other events, such as our Retirees' Dinner. The Branch loves to see great use of the hall and to have it filled with our members.

I hope to see many of you at the next meeting on January 27, 2026. Let's go ahead and get 100 members so I can get dunked before it gets warm.

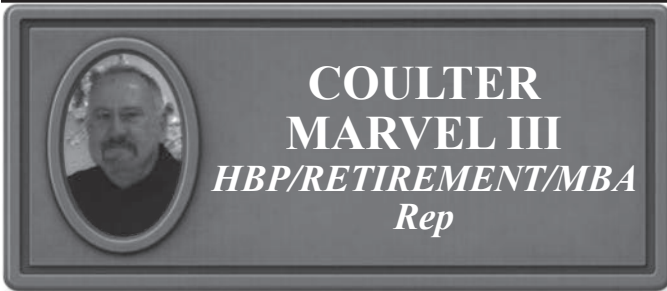

Welcome to 2026

Update for New Retirees

Effective January 1, 2026, the Postal Service will require all optional retirement applications be submitted online through ORA (Online Retirement Application) platform, in accordance with OPM's mandate.

Accordingly, all newly received optional retirement applications will be processed through the ORA platform. This secure, fully digital system will be administered by the OPM and will allow applicants to complete retirement applications online, track the application status, and expedite processing time. Optional retirement applications submitted prior to January 1, 2026, regardless of the effective retirement date, will continue to be processed using the paper-based process and do not need to be resubmitted.

The Postal Service will be providing Frequently asked Questions and additional information in the Retirement Guide regarding this mandated application process in the coming weeks.

So, what does this mean? I will be in the learning curve with you. I can assist with computer time in the office to help fill out your application, upload documents for you and answer questions as we go through this new process together.

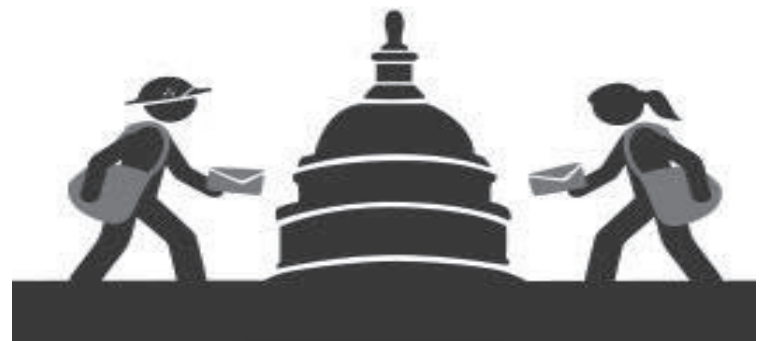
We hope this will speed up application processing time and eliminate human errors on OPM's side. As time goes on, I will determine how I can better help each of you in this new process.

Secondly, don't forget your NALC Health Benefit Plan Telehealth the next time you're sick.

1. Get Started
Download the NALCHBP Telehealth App or go to www.nalchbptelehealth.org.
2. Sign Up
Enter your health plan ID to see your visit cost.
3. Connect To a Doctor
Select "visit Now" under "Urgent Care Services" to see a doctor in minutes.

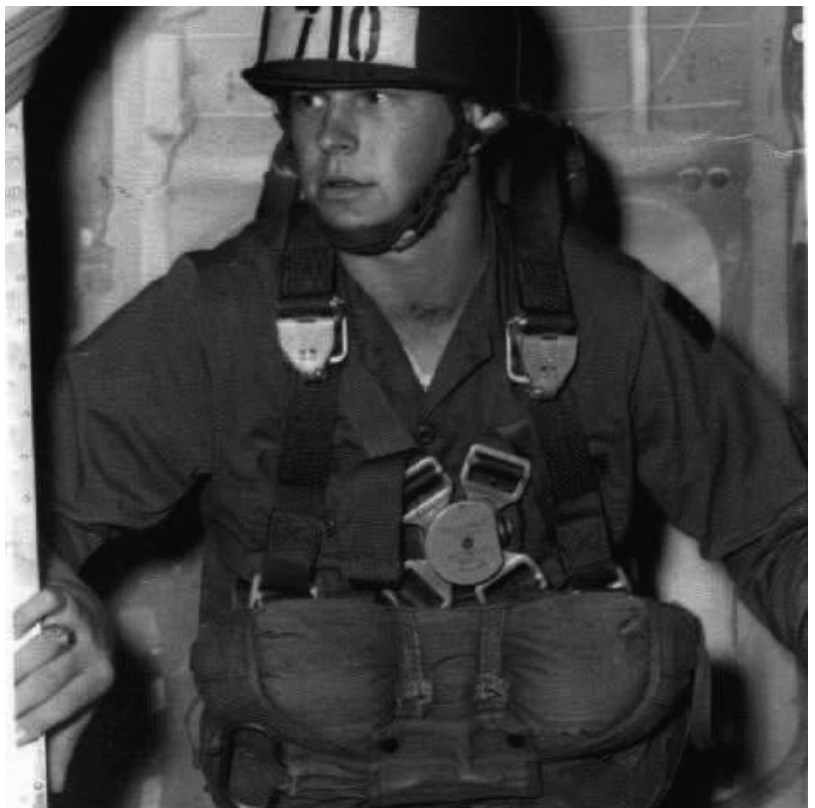

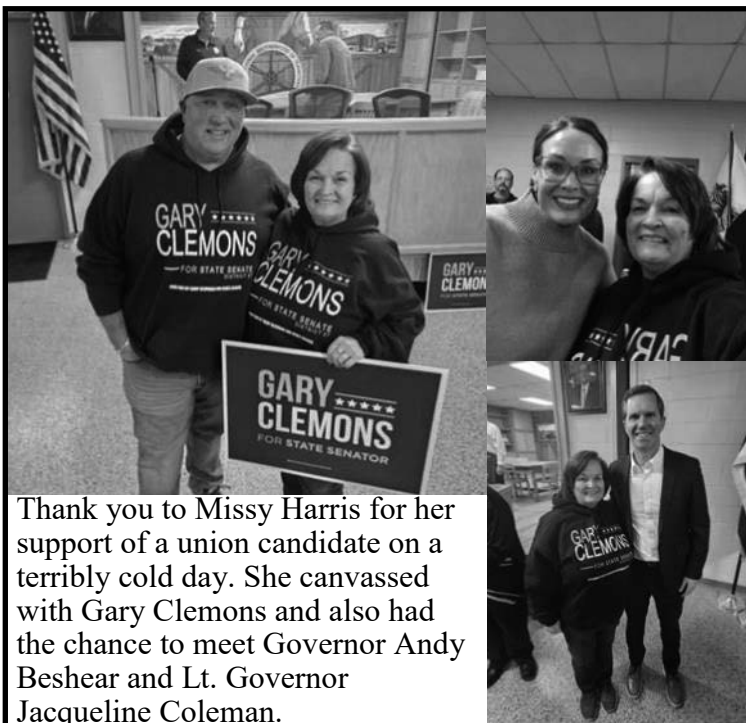
**DELIVERING NALC'S

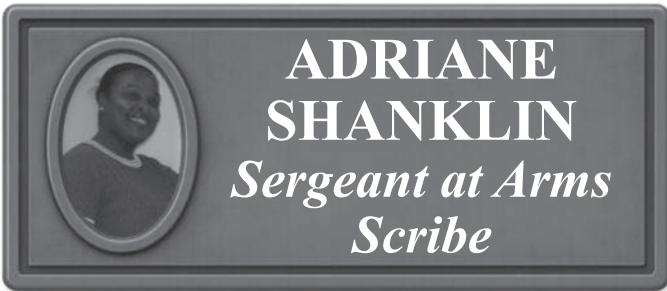
