This is the official notice to all members of Branch 14 of the nominations and elections for all officer positions for the three (3) year term beginning January 1, 2025. There will also be nominations and election of delegates to the 2025 Kentucky State Association of Letter Carriers convention.

Nominations will be accepted at the regular monthly meetings of Branch 14 on Tuesday, August 27 and Tuesday, September 24, 2024. Elections will be held on Wednesday, October 23 from 4:00 P.M. until 8:00 P.M. and on Thursday, October 24 from 5:00 P.M. until 9:00 P.M. All nominations and voting will be conducted at the Branch 14 Union Hall, 4815 Poplar Level Road, Louisville, KY, 40213. The Kentucky State Association Convention will be held in Bowling Green, Kentucky on June 8 & 9, 2025.

The number of delegates allowed to attend the convention will be determined in accordance with the Constitution of the National Association of Letter Carriers. In accordance with Branch 14 By-Laws, the President, Executive Vice-President, Vice-President, Recording Secretary, Assistant Recording/Financial Secretary and Treasurer will be automatic, paid, delegates to the Convention. The remaining number of paid delegates to the convention will be determined in accordance with Branch 14 By-Laws.

Voting will be by secret ballot and the results will be posted on the Branch 14 website at www.nalcbr14.com and read at the regular monthly meeting on Tuesday, November 26, 2024.

Any member that will be unable to vote during the times that the polls are open may request an absentee ballot. The request must be made in writing, with name and address of the member requesting the absentee ballot. The request must have a legible signature by the member requesting the absentee ballot.

Requests for absentee ballots must be received by the Branch 14 Election Committee between the dates of September 25 and October 10, 2024. Requests should be sent to: NALC Branch 14 Election Committee, PO Box 34572, Louisville, KY, 40232-4572. Absentee ballots must be returned to the Election Committee by October 24, 2024. All requests for ballots received after October 10 and returned ballots that are received after October 24, 2024 will be void. These requests and ballots will be kept as a matter of record by the Election Committee.

All regular members in good standing shall have the right to nominate a candidate for any officer position or delegate to the National Convention. Self-nomination is permitted. All qualified regular members shall be eligible to be an officer, delegate or an alternate delegate to the State Convention except as provided for in accordance with Article 5, Section 2 of the Constitution of the National Association of Letter Carriers and Article 7, Section 2 of the Branch 14 By-laws.

The Louisville installation has a vacant route posting every 4 weeks. The posting opens on a Tuesday (unless it is a holiday, then it opens on Monday) and is posted for ten (10) days, closing on the following Thursday (unless it is a holiday, then it closes on Friday). We normally get notification on the following Monday of the "Pre-Awarding", which is the initial report of who the senior bidders were. This is not published as it must be verified that each successful bidder was qualified to bid when they did. In a recent posting we had a carrier bid who had medical restrictions and failed to provide required medical certification prior to the closing of the bid cycle. Therefore, the assignment was awarded to the next senior bidder. This does not happen often, but when it does, it could really screw up and delay the awarding. For example; the carrier who was finally awarded the position could have also been senior bidder on another assignment. If that had been the case, then the snowball effect comes into play, determining who the senior bidder of that assignment is, and so on. Fortunately, in this case, the most senior bidder was not a successful bidder on another assignment and was awarded the assignment.

This statement is on the cover sheet of the route posting:

If you bid and are currently on light or limited duty or are receiving COP or compensation, sick leave, annual leave or LWOP in lieu of sick leave you must provide medical certification BY THE CLOSE OF THE POSTING. This certification should indicate that you will be able to perform the duties of the bid for position within six (6) months of the bid. This medical certification should be submitted in a separate sealed envelope addresses to the USPS Medical Unit, using complete address.

The contract language for this can be found in Article 41.1.C.1. I am not posting that here as it would consume much space. You can find this info in the JCAM on the Branch 14 website at www.nalcbr14.com. If bidding with the above listed qualifications, please ensure that you submit the required certification prior to the closing date

(Thursday) of the route posting. Otherwise you may find yourself not being declared the "successful" bidder.

Another reason that a carrier may not have been qualified to bid would be the issue of a carrier serving as a 204b (pretend supervisor). The JCAM states in Article 41.1.A.2:


"Letter carriers temporarily detailed to a supervisory position (204b) may not bid on vacant Letter Carrier Craft duty assignments while so detailed. However, nothing contained herein shall be construed to preclude such temporarily detailed employees from voluntarily terminating a 204b detail and returning to their craft position. Upon return to the craft position, such employees may exercise their right to bid on vacant letter carrier craft duty assignments."

A key point of this provision is where it says "nothing contained herein shall be construed to preclude such temporarily detailed employees from <u>voluntarily terminating a 204b detail</u> and returning to their craft position." This means that they would have to "terminate" or "end" their detail, not just step down for the day". However, our Local Agreement addresses the issue further. Item 22, Section I states:

- 2. A 204b carrier desiring to place bids on vacant carrier positions must be in a carrier status at the time of bidding and must have worked a minimum of two (2) service weeks in the previous four (4) month period.
- 3. A 204b carrier whose duty assignment was declared vacant in accordance with Article 41.A.2 and desires to bid on vacant carrier positions must return to the craft for a period of not less than two (2) service weeks and be in a carrier status at the time of bidding. Any period between the last day of a route posting and first day of route awarding will not be counted towards the two (2) service weeks. An exception to this rule will be made in situations where the 204b's detail has been permanently ended.

The 204b issue comes up more often than you think, so if you are a carrier who feels that you have to be a pretend supervisor, you must follow the above listed requirements, or you may also find yourself not being declared the "successful" bidder.

I hope to see many of you at the next meeting on Tuesday, September 24th at 7:30 pm. Knowledge is power. Solidarity forever!

Often in the early dawn hours, I find myself awake and thinking of my union work. From contractual grievances at the informal A level and also discipline cases at the Formal A. Sometime almost like revelations, great arguments and contentions come to mind. Or, maybe I'm just dreaming.

I think I do know the actual way to develop great arguments and contentions: repetition, execution and learning from failure. Author and Journalist Malcolm Gladwell popularized the idea of the "10000-hour rule" in his book *Outliers*. The 10,000 Hour Rule suggests that it takes approximately 10,000 hours of deliberate practice to achieve mastery in any field. I like the idea, but that is a lot of time. That is 416 days or 1250 eight-hour work shift. As Letter Carriers, with vacation, holiday and sick leave, it takes almost four years for us to achieve 1250 eight-hour days.

Is there another option? I believe so, and it does incorporate my thoughts and those of Mr. Gladwell. It combines the repetition idea and a deliberate practice to inform our members. We do this through steward training, through branch communications, including this newsletter, and with stewards informing our brothers and sisters on the workroom floor.

I often comment that in union parlance, besides general union activities, you don't want to be in continual contact with me as a union official. Most frequently when your file hits my desk, it's for discipline. Most times when I walk into the Okolona Post Office I hear, "Who's in trouble now?"

I have been a part of hundreds of Pre-Disciplinary

Interviews (PDI). My job in that role is to advise and protect our members. When a steward sits in a chair next to you, they have the same rights as a manager. They are there to actively participate. That begins with the consultation beforehand, taking vigorous and accurate notes during the PDI and asking questions at the end to help clarify your answers or shed light on the situation for management. As management likes to say: "Remember this is your day in court."

The term PDI is accusatory in nature in my opinion. While management has the right to investigate a situation, a PDI assumes there will be Discipline coming. Other areas use the term Investigative Interview and I believe it a fairer term, but again it is management's right and term. Going into a PDI can be intimidating and scary. If it is your first time, listen to your steward, they will have good advice.

As each PDI is different, my goal is to inform you on what a PDI is like. This won't be a one-month process. As I continue to write these, I will do my best to illustrate the type of question you will receive and how *I would answer*:

In closing this week, I will start with the opening of the PDI. Typically, management will ask you about a series of provisions from the Employee-Labor Manual or the ELM. They typically read them to you and then ask at the end if you understand them. The ELM is massive. It has so many provisions, rules and regulations that it would be extremely impossible to totally grasp. If you are asked about a provision and you don't understand that, then say it. It is okay to be unclear about rules that we may not know. It could also provide an argument to the union if management continues and does not address your uncertainty.

As I stated earlier, the steward will be there recording your answers, so speak slowly and clearly. It is okay to ask for a copy of the notes from your PDI. Also understand that a PDI may not lead to discipline. So, while we want to be cognizant that something may happen, only communicate with your steward regarding the PDI. We will continue the PDI process next month.

The union meeting is on September 24, 2024. I hope to see many of you there.

Open Season Nov. !!, 2024 through Dec. 9, 2024.

Postal Service Health Plan Program (PSHB), is the 2025 new health plan for most postal employees and retirees. This is a separate program within the FEHB and will be administered by the Office of Personnel Management (OPM).

This FEHB Program will be effective on Jan. ! 2025. All active and retirees will be moved into a new plan within the current program into the PSHB plan. You will have the opportunity to review PSHB plans and make a selection during the Open Season. If you do not make a plan selection during Open Season a comparable plan will be selected for you by OPM. Members who are on Medicare Part A&B will receive information from OPM prior to the Open Season. The USPS will send information to active employees.

This is a normal Open Season. We have been doing this for long time. If you are satisfied with your current plan, you can keep it or change to a different plan. Once you change, you will be required to sign up in the PSHB of your choice for 2025.

Prior to 1920, it was possible to send children through the US Postal service. However, there were certain conditions that needed to be met. Firstly, the children had to weigh less than 50 pounds, and stamps were attached to their clothing as a form of payment. Surprisingly, it was often more cost-effective for individuals to send their children via mail rather than opting for train transportation. Interestingly, during the journey, the children would travel on a train, specifically in the mail car, where they were supervised and provided with nourishment by mail clerks. One remarkable example of this unconventional practice involved a distance of over 700 miles, from Florida to Virginia, covered with a mere 15 cents worth of stamps.
