**New Year's GED® Ready Campaign**

# **Your GED® students might be eligible to take a GED Ready® exam right now!**

**Check to see if your students are eligible below:**

- Student TABE Pretest or Posttest score is NRS level 4 or higher
- Student has completed all registration forms and have submitted the ASPD to Kimee
- Student has at least 12 verifiable hours of attendance
- Student has created a ged.com account and has released the scores to MRRAEP

**If you answered yes to all of the above, then email your request for a GED Ready® voucher using the guidelines below with the student's name to Debbie Roark ([debbieroark@scsb.org](mailto:debbieroark@scsb.org))**

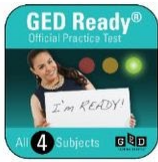
- o Students who score NRS level 4 or higher in Reading will be eligible for GED Ready® vouchers in RLA, Social Studies, and Science
- o Students who score NRS level 4 or higher in Math will be eligible for a GED Ready® voucher in Math

**\*Please do NOT contact Debbie for a voucher if the above criteria have not been met.**

**All GED Ready® vouchers must be used by March 31, 2023**

## **REMINDERS:**

- Please be diligent about making sure your students are getting in 40 hours and taking a post test before scheduling the last official GED® subject test.
- This campaign is in addition to our normal qualifying policies of passing scores in Essential Ed and Aztec online learning programs.
