Tax collection hours remain the same. I am in my office on Tuesdays and Fridays from 9 am – 4 pm. Taxes can be paid during normal business hours, or use our drop box, or pay online. This information is available on our Township website (www.frankenlust.org). Summer taxes and deferments are due by September 14, 2020, before and I will be in the office until 5:00 p.m. If you are having a hard time paying your taxes, please contact my office, as there are a few programs available that might help. Remember, I do also accept partial payments. Please pay by check, money order or cash. Payments in CASH must be exact as we will not be able to make any kind of change for you. I will have an envelope to put your cash into when you come into the office. We do NOT accept credit cards at the Township office, only online through our website.

We are also looking at possibly putting a drive-up mail drop box for such things as tax payments, election applications and ballots just so we can limit the amount of people coming into the township hall. Look for more information on our website about that.

Dealing with an election in August and November in the midst of COVID-19 is confusing and challenging. Many state agencies, including the Bureau of Elections, Secretary of the State, and the Michigan Township Association are weighing in on their views and guidelines of what to do as we prepare for these elections. As it stands now, the Absentee Voter Applications will be mailed from the Township in early June for registered voters already on the permanent absentee voter list. If you are not on the permanent list, an application will be mailed to you from the State of Michigan giving you the opportunity to apply for an absentee ballot for the 2020 elections. I know many of you have already indicated that you wish to receive an absentee ballot for November when you completed the form back in March. The forms have changed and you will need to complete the new forms being sent out to request a ballot for August and November elections. If you do not receive an application in the mail, feel free to contact me at daf_clerk@frankenlust.com or 989-686-5300 as I would be glad to mail one to you. On the ballot for the Township positions are: Supervisor – Ronald Campbell (incumbent) and Daniel Ruff; Clerk: Deborah Fisher (incumbent) – unopposed; Treasurer: Gayle Ortner – unopposed; Trustees: James Begick (incumbent), Samuel Britton (incumbent), David Phillips, and Ann Krauss. I hope all of you are staying well and safe and continue to do so.

SZoning Administrator - Rodney Nanny

Are you contemplating plans for a new shed, fence, addition, or some other building project? The Township requires zoning and building permits for these improvements to verify that state construction code and local ordinance requirements have been met. A zoning permit is required for any new sheds over 100 square feet in floor area, and for decks, swimming pools, fences, garages, pole barns, and any other accessory structure or addition. Be sure to check out the Township's Zoning Ordinance online at http://www.frankenlust.com for the rules that apply to your project. Permit application forms are also available on the Township's website or at the office during business hours. Michigan cities and townships are authorized to enact ordinances for the promotion and protection of the public health, safety, and welfare, which include the Township's Blight Ordinance and Dilapidated Buildings Ordinance. The Township Board has maintained a consistent enforcement policy to require repair or removal of dilapidated structures, clean-up of blighted properties, removal of inoperable or unlicensed vehicles, and correction of other unlawful conditions governed by these ordinances.

2020 has been a unique experience for the entire world in the wake of Covid-19. Following federal, state, and local guidelines the Frankenlust Township Fire Department is prepared and has taken necessary precautions to protect our firefighters and the community we serve. Our staff have received additional training throughout the pandemic to keep up-to-date, following the most current recommendations for personal protective equipment for crew and patient safety. We will continue to be ready and available to serve the township with any fire/rescue service needs The fire department finished 2019 with 389 calls, a record high call volume for us. This pattern of increasing call volumes over the past number of years will likely end in 2020. Nationwide, calls for emergency services declined dramatically the past few months. Emergency protocol changes within the Bay County Medical Control Authority (our governing body for medical services) also resulted in reduced medical responses for local fire departments briefly during the peak of the pandemic. Volume has been picking back up and we are seeing a return to "normal" call volume in the last few weeks. The Frankenlust Township Fire Department would like to thank our residents and businesses that have continued to support and recognize us during these unusual times. We are grateful for the appreciation, words of encouragement, and donations that we have received! Have a safe and enjoyable summer!
