RECYCLING: Please take note that the new Waste Management Contract includes a surcharge if the recyclable guidelines are not followed. Below are the guidelines:

RECYCLABLES must be dry, loose (not bagged) and include ONLY the following:

Aluminum cans - empty	Newspaper
PET bottles with the symbol #1 - with screw tops only - empty	Mail
HDPE plastic bottles with the symbol #2 (milk, water bottles detergent, and shampoo bottles, etc.) - empty	Uncoated paperboard (ex. cereal boxes; food and snack boxes)
Steel and tin cans - empty	Uncoated printing, writing and office paper
Phone books	Old corrugated containers/cardboard (uncoated)
Magazines, glossy inserts and pamphlets	

RECYCLABLES may include the following with the written consent of WM:

Plastic containers with symbols #3-#7 - empty (no expanded polystyrene), empty	Glass food and beverage containers - brown, clear, or green - empty
Aseptic containers	Cartons

NON-RECYCLABLES include, but are not limited to the following:

Plastic bags and bagged materials (even if containing Recyclables)	Microwavable trays
Mirrors	Window or auto glass
Light bulbs	Coated cardboard
Porcelain and ceramics	Plastics unnumbered
Expanded polystyrene	Coat hangers
Glass and metal cookware/bakeware	Household appliances and electronics,
Hoses, cords, wires	Yard waste, construction debris, and wood
Flexible plastic or film packaging and multi-laminated materials	Needles, syringes, IV bags or other medical supplies
Food waste and liquids, containers containing such items	Textiles, cloth, or any fabric (bedding, pillows, sheets, etc.)
Excluded Materials or containers which contained Excluded Materials	Napkins, paper towels, tissue, paper plates, paper cups, and plastic utensils
Any Recyclable materials or pieces of Recyclables less than 4" in size in any dimension	Propane tanks, batteries

DEBBIE FISHER - The Clerk's office has been very busy as we expected. The November 3, 2020 General Election is only one week away as of this writing. We have approximately 3100 registered voters in Frankenlust Township. Normally about 300-400 absentee ballots are issued. August State Primary saw a request for over 800 absentee ballots. We currently have over 1400 absentee ballots that have been issued, that is 45% of our registered voters that have asked for an absentee ballot. Everyone knows that this is a very important election and want their voices to be heard. Voting is the way to do that. I am so proud of the response that we have received. I have been able to meet and talk with residents that I haven't met before and many that I don't get a chance to see often. We have also had a good response for our request for more election inspectors at the poll. Thank you to those for offering to help. Michigan cities and townships are authorized to enact ordinances for the protection of public health, safety, and welfare. For example, the Board of Trustees have maintained a consistent enforcement policy to require repair or removal of dilapidated structures, clean-up of blighted properties, removal of inoperable or unlicensed vehicles, and correction of other unlawful conditions governed by the Township's blight and dilapidated buildings ordinances. The Township's Zoning Ordinance regulates the intensity and arrangement of land uses, structures, and site improvements. A zoning permit is required for new homes and additions, for decks, pools, garages, and pole barns, and for most fences and sheds. Site plan approval is required from the Planning Commission for larger land development and construction projects. As first responders, the Frankenlust Township Fire Department continues to monitor the evolving federal, state, and local guidelines related to Covid-19 to remain up-to-date and prepared to continue protecting our firefighters and the community we serve. We will continue to be ready and available to serve the township with any fire/rescue service needs throughout these trying times with the necessary training and equipment. In partnership with the American Red Cross, we are participating in the *Sound the Alarm Home Fire Campaign* to install FREE smoke detectors in township residences without working smoke detectors or for those who have smoke detectors older than 10 years.
