The regular meeting of the Township Board was called to order by the Supervisor, Ron Campbell. Present were Revord, Fisher, Campbell and Begick. Britton was excused. The Pledge of Allegiance was said in unison.

Minutes. Motion by Fisher/Revord to approve meeting minutes for the 9-12-17 meeting. 4 aye, 0 nay. Carried.

<u>Treasurer's Report</u>. Motion by Revord/Campbell to approve the Treasurer's reports as presented. 4 aye, 0 nay. Carried.

<u>Copier</u>. Motion by Revord/Fisher to purchase Kyocera for \$3,968.00 and a 36-month service agreement for \$16.00

per month plus \$0.0129 per page printed. Includes Toners, Maintenance Kit Components (drum, developer, diffuser). All service parts & labor included. 4 aye, 0 nay. Carried.

<u>Fire Department</u>. A written report from Bryan Kukla, Frankenlust Township Fire Chief, is on file. There were 31 calls in September, 2017: 0 Fire, 22 EMS/Rescue, 7 Good Intent, 0 Hazardous Condition, 2 Service Calls and 0 False Alarm, with YTD total of 285 calls.
