NEW POLICE AND FIRE PROTECTION MILLAGE

There will be a question on the August ballot regarding a new millage for the Township of Frankenlust for the Fire Department and Police.

Ninety percent of this millage will fund the Fire Department allowing the Township to allocate \$300,00-\$400,000 a year in road maintenance and construction without a separate road millage.

Here are a few reminders as we start a new tax year. When you are looking over your Summer Tax bill, be sure to review the information carefully. If any corrections are needed, contact us immediately.

Please be aware that the mail can take 2-4 days to be delivered, so keep this in mind when you pay close to the last day in order to avoid late charges. Also, your tax bill includes your receipt. If you pay by mail, tear off only the bottom portion and mail with your payment. Keep the top portion as your receipt. Remember you can pay your taxes by (1) mail, (2) drop box located outside the front entrance, (3) in person, and (4) online through our website, but there is a convenience fee added. If you pay by mail or drop box and would like a paid receipt, you must enclose a stamped, self-addressed envelope. Partial payments are accepted. Cash, check or money orders are preferred payments. I would please ask that IF YOU PAY IN CASH THAT YOU HAVE THE EXACT AMOUNT.

For those who defer their taxes, you should have also received your application in the mail. Remember, a new form needs to be completed each and every year. If you have any questions, kindly give me a call (989-686-5300).

We are also at the start of a new budget. Again, if it weren't for the revenue sharing we receive from the state, we would be unable to do many of the larger projects, such as roads, here in the Township.

The Frankenlust Township Planning Commission is currently studying the possibility of an improvement project for the Westside Saginaw Road (M-84) corridor, which runs through the Township from Hotchkiss Road to Freeland Road and includes the I-75 interchange (exit 160).

The purpose of the study is to look into viability of enhancing the Township's appeal to both residents and potential new businesses. Possible enhancements may include improvements

within the Squaconning/Dutch Creek watershed to make it more accessible to the public, new opportunities for housing and commercial activities, lighting upgrades, and other improvements to create a consistent visual appearance along the corridor.

The Planning Commission is very excited about the study. This project has the potential of bringing the residents and current businesses together to strengthen unity within the Township and making it an even nicer place to live.

Our Primary Election will be August 7th and the General Election will be November 6th. We continue to vote at the LFA Hall, 2323 Amelith Road. Since this is a big year for elections with the governor and many other government positions open, you may see long lines at the polls.

If you are 60 or older, out of town that day or have trouble getting to the polls, you may vote by absentee ballot. To do this, stop in at the Township Hall or call me and sign up for permanent absentee ballots. Once you are on the permanent absentee voter list, you will automatically remain there unless you request to be removed. An absentee application will be sent approximately six weeks before each election for you to complete and request an absentee ballot to be mailed to you. If you are not registered, please do so before July 9, 2018. Michigan Election Law requires first time registered voters in the state of Michigan to register by mail to vote in person their first time.

If you would like to use the pavilion area for a gathering, please call or stop in to the township offices and reserve your day and time. The cost will now be refundable deposit of \$25.00 for the day.

Zoning Administrator -- Rodney Nanny

Are you contemplating plans for a new shed, fence, addition, or some other building project? The Township requires zoning and building permits for these improvements to verify that state construction code and local ordinance requirements have been met. A zoning permit is required for any new sheds over 100 square feet in floor area, and for decks, swimming pools, fences, garages, pole barns, and any other accessory structure or addition. Be sure to check out the Township's Zoning Ordinance online at http://frankenlust.com for the rules that apply to your project.

Permit application forms are also available on the Township's website or at the office during business hours.

Michigan cities and townships are authorized to enact ordinances for the promotion and protection of the public health, safety, and welfare, which include the Township's Blight Ordinance and Dilapidated Buildings Ordinance. The Township Board has maintained a consistent enforcement policy to require repair or removal of dilapidated structures, clean-up of blighted properties, removal of inoperable or unlicensed vehicles, and correction of other unlawful conditions governed by these ordinances.
