The Kochville and Branches Intercounty Drain Drainage Board, which for purposes of this meeting shall include the Bay County Drain Commissioner, Saginaw County Public Works Commissioner, and Michigan Department of Agriculture and Rural Development, will meet at the above date, time and location to hear all interested persons, receive evidence and determine whether the removal of Bay County from the Kochville and Branches Intercounty Drain Drainage District is just and equitable pursuant to Chapter 8 of Public Act 40 of 1956, as amended. The Drainage District currently consists of lands located in Bay County and Saginaw County. All persons owning lands in the Drainage District or proposed revised Drainage District liable to assessment for benefits and any municipality affected may appear for or against the removal of the County.

A map depicting the proposed revised drainage district with the removal of Bay County from the Drainage District can be found enclosed.



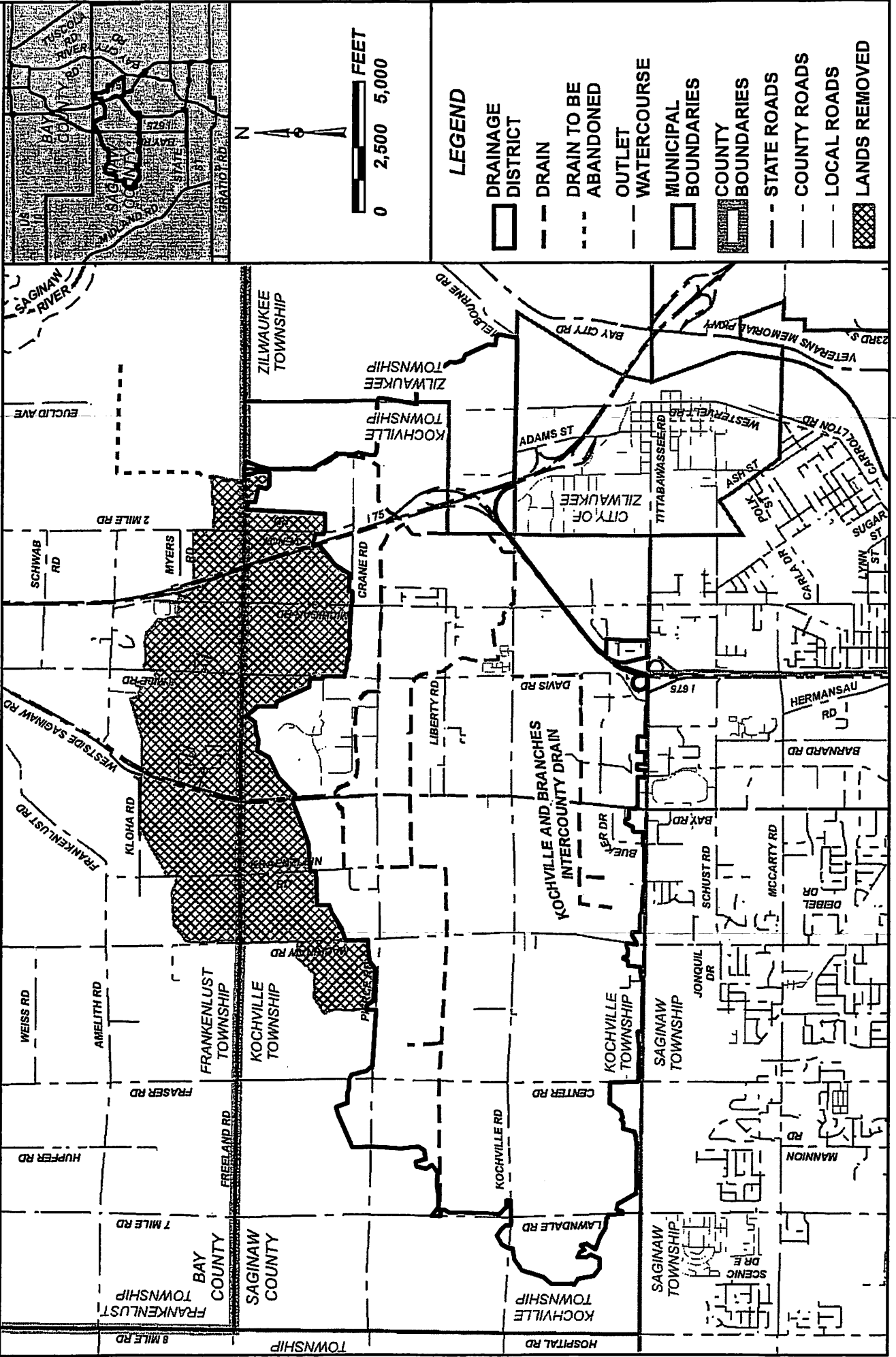
