## **Permit Form:**

Form: Burn Permit

Description: Open Burning is only allowed with a BURN PERMIT in Frankenlust Township. Residents must first obtain a burn permit by visiting or calling the Township Office at 989-686-5300. Requests for a burn permit may be left on voicemail after listening to the burn permit/open burning rules and restrictions. By provided your required information you agree to the terms listed in the announcement and will comply with the following:

## **Permit Topics:**

#### Rules

Burn permits are FREE, valid for a maximum of three days at a time, and can be renewed as many times as you need them.

Open burning pollutes the air and poses a fire hazard. The air pollution created can irate eyes and lungs, obscure visibility, soil nearby surfaces, create annoying odors, and is a threat to those with respiratory conditions. Even with a burn permit obtained, open burning may NOT create smoke or odor nuisances.

Open burning is for YARD WASTE ONLY. Permitted items include: tree limbs, logs, brush, stumps, leaves and grass.

Open burning must be ATTENDED at all times by a competent adult

Open burning MUST have a water supply or other fire extinguishing equipment readily available for use

Open burning shall NOT be within one hundred feet (100') of any structure

Open burning is only allowed during DAYLIGHT hours.

Open burning is NOT allowed within 1,400 feet from the boundary of the city limits (Bay City).

NO BURNING of trash, rubbish or garbage.

NO BURNING of any structures (houses, barns, or sheds)

No BURNING of pressure treated lumber, tires, oil-based products, or bedding/mattresses.

NO BURNING of construction, remodeling, repair, and demolition waste or packaging.

#### Restrictions

Conditions may change from the time the permit is issued resulting in burning restrictions during the permit period. Residents must verify burning is still allowed each day before burning by contacting the township or visiting the DNR website at http://www.dnr.state.mi.us/burnpermits/

On the DNR website interactive map when Bay County is: "ORANGE" - burning is allowed by permit in Frankenlust Township | "BROWN" - burning is restricted by the DNR and no burn permits will be issued/allowed.

## **Enforcement**

Any complaints will result in the fire department being dispatched to investigate. If found to be in violation of any of the rules, the fire shall be extinguished, the permit shall be revoked, and you will be responsible for any costs that are incurred in accordance with the township cost recovery ordinance.

If you have requested a permit and the fire gets out of control, the fire department will respond once notified and you may be responsible for any costs incurred in accordance with the township cost recovery ordinance.

### Recreational

Recreational fires shall not be conducted within 25 feet of a structure or combustible material. Conditions that could cause a fire to spread within 25 feet of a structure shall be eliminated prior to ignition.

Small recreational burning of logs, brush, charcoal, and other similar materials for the purpose of pleasure, religious, ceremonial, cooking, warmth or similar purpose is allowed without permit. Recreational fires may be prohibited if the DNR issues a burning BAN due to dangerous fire conditions.

Recreational fires shall be limited to a total fuel area of 3 feet or less in diameter and 2 feet or less in height.

#### **Administrative**

In Michigan, open burning is regulated by the Natural Resources and Environmental Protection Act (Act 451 of 1994) and associated rules. The act includes: Air Pollution Control - Part 55, Solid Waste Management - Part 115, Forest Fire Prevention - Part 515; Frankenlust Township Solid Waste Disposal Ordinance 8A

#### Agricultural

Agricultural burning is allowed without permit if the fire is part of the cropping or approved disease/pest control system.

Agricultural burning still REQUIRES a burning permit for clearing land that has not been cropped in the previous year, burning a road shoulder, burning yard/tree clippings or vegetative debris or clearing/burning an area not considered part of the farm cropping operation.

Agricultural exemptions do NOT include clearing land, burning road shoulders, burning fertilizer bags, chemicals, or tires.

NOTE: You are strongly encouraged to notify the Fire Department of an agricultural burn even when the above practices are followed. You are still responsible for monitoring and managing any fire started.
