The regular meeting of the Frankenlust Township Board was held. It was called to order by Supervisor Ron Campbell.

Motion by Begick/ Britton to approve the regular board meeting minutes from December 10, 2025, accept the Treasurers Report and authorize payments of bills in the amount of \$102,816.20. Discussion Roll Call Vote: Britton- Yes, Stothard-Yes, Begick-Yes, Lapan-Yes, Campbell-Yes. Motion Carried.

Motion by Campbell/Begick to accept the 3-year agreement for the years 2026 in the amount of \$11,800.00, 2027 in the amount of \$12,200.00, 2028 in the amount of \$12,600.00. Discussion. Roll Call Vote Begick-Yes, LaPan-yes, Campbell- yes, Britton-yes, Stothard- yes. Motion Carried.

- Billys Proposal- An estimate to fix a pipe for the Fire Department was presented before the board. The Supervisor will contact Super Construction for another bid/opinion.
