Call to order: Chair Terri Scheuerlein called the meeting to order at 7:01 PM.

Review of Minutes: Lyndsey O'Brien **motioned** to approve the December 10, 2025 Regular Meeting minutes. Dave Helmreich seconded. **Motion carried.**

Public Comments: None.

Old Business: a. **Special Data Centers**

Mike Daily-Martin presented a draft proposal for an ordinance for Frankenlust Township to regulate data centers.

Questions and concerns were brought up by several Commission members regarding the location and requirements of such facilities, and especially regarding water and power usage. Mike will follow up on these issues and present proposed ordinance wording to address these issues at a future Commission meeting.

No action by the Planning Commission will be taken until a modified draft ordinance is ready for appropriate disposition and approval.

b. Short-term leasing

Mike presented a draft proposal for changes to section 25.03 of the Frankenlust zoning ordinance including 6.02 "Table of Permitted Use by District" and 25.03 "Definitions" in order to distinguish between and properly regulate the usage of these two types of residences.

A discussion ensued between Mike and various members of the Commission. Mike will follow up on some of the issues discussed and present his findings at the next Commission meeting. No action by the Planning Commission will be taken at this time.

New Business: Cold storage addition for Twin Oaks Golf Course

A site plan for this small addition was provided by Twin Oaks. Jim Begick motioned to approve the plan as represented. Dave Helmreich seconded. **Motion carried.**

Building Inspector: Building Inspector's report for December 2025 was reviewed and is on file.
