A spreadsheet outlining proposed salary adjustments for the upcoming fiscal year was presented to the Board for review. Moving forward, the Building Official and Zoning Administrator will have an indefinite contract. **Motion by LaPan/Stothard to approve preliminary budget salary increase 2026-2027 with Administrative Assistant position pending the review to be effective July 01, 2026. Discussion.**

**Honor Security:** Quotes from Honor Security for installing a surveillance camera system to monitor the inside and outside of the building to be installed in July. **Motion by Stothard/Britton to accept the Honor Security estimate of \$5,514.00 for additional cameras and equipment. Discussion.**

**Upcoming Road Projects:** Bay County Road Commission & Frankenlust Township Agreement 213914 to perform rubber chip seal over existing pavement, fog seal, and durapatch for the estimated cost of \$190,670.00 for the roads listed **\*below\***. The Supervisor will verify with Bay County Road Commission to provide a map or keep us informed on roads being worked on for emergency preparation for our Fire Department. **Discussion on this topic to be voted on during the Budget Public Hearing on June 16, 2026.**

**Helmreich AG, Products LLC:** The Board looked over amendments to an agreement for Helmreich AG, Products LLC which started April 16, 2026 and expires on April 16, 2027. Pricing for mowing secondary roads, blight, and the Old Hickory Estates Retention Pond. **Motion by Britton/Campbell. Discussion. 5 Aye 0 Nay. Motion Carried.**

**Resolution 2024-002A:** Resolution 2024-002 wording was amended to reflect permits based on the State Building Code and Building Permit Fee Schedule. **Motion by Campbell to approve the amended 2024-002A resolution effective immediately. Discussion.**

**Roll Call Vote:** LaPan-Yes, Begick-Yes, Stothard-Yes, Britton-Yes, Campbell-Yes. **Motion Carried.**

**Electrical/Mechanical/Plumbing Inspector:** Agreement has changed from contract employee to employee. Pay was changed from 85% of the permit fee to 80% of the permit fee to cover the cost of taxes. Mechanical/Plumbing inspector agreement is now a continuous agreement and no longer will be reviewed annually. **Motion by Britton/LaPan to approve contract changes to Electrical Inspector & Mechanical/Plumbing Inspector agreements. Discussion.**
