Fire Department Fire Department meeting minutes from November 2, 2023 are on file. Runs for October totaled 44 with a YTD total of 426. Captain Anthony Passariello announced his retirement effective immediately on October 11, 2023. Lieutenant Markle was promoted to Captain. The vacant position of Lieutenant will not be filled at this time. Christmas party is scheduled for December 8, 2023 for the annual celebration. December 9, 2023 is scheduled for the Santa party inviting FD and Township staff to bring their families. Email and Facebook invitations were sent to fire department members, township officers and staff. Two unpaid accounts have been sent to litigation for processing. Supervisor Campbell requested a quote to have the overhead power lines removed and put in the ground to make it easier to have the flight care helicopter land when needed. There has been no response as of today. New Fire Department applicant, David Kerns, has passed all requirements to be a member of Frankenlust Township Fire Department. He has past fire experience so he doesn't need to take the full academy training. He will be going through the monthly trainings since it has been a significant amount of time since he has received any training. He will need to attend the medical training that will be available fall 2024 for his EMR. Motion by Britton/Fisher to approve Fire Chief Kukla recommendation to hire David Kerns to be a member of the Frankenlust Township Fire Department. 4 aye, 0 nay. Carried.

Zoning Amendments Discussion on approving the new Zoning amendment article 4.100 and 6.0 land use table. Basically, states that if property is zoned as C-3, everything that is covered in C-1 and C-2 are included in C-3. <u>Baywoods Condo Assoc</u> Representatives from Baywoods are seeking the Township's guidance and information on the entire topic of WM totes versus the use of a dumpster. Our discussion focused on

the difficulty of using the new totes by their residents and lack of storage space. They were given specifications for constructing a dumpster enclosure. It was also suggested that the Board provide the Baywoods Representative with a written summary of all specifics having to do with all of their **options** and **quidelines** as outlined by the Township Board.

Road Patrol Discussion on new contract for 2024. There will be an increase in cost for our Road Patrol officer from \$48,100 to \$52,800 for 2024. Motion by Campbell/Fisher to approve the contract 2024 Agreement for Special Police Protection between Frankenlust Township and Kawkawlin Township through the Bay County Sheriff Patrol Services. <u>State Tax Commission</u> State of Michigan Department of the Treasury sent a letter to Supervisor Campbell indicating that the State Tax Commission held a meeting October 23, 2023. They certified and returned the jurisdiction of the 2018, 2020, 2021 and 2022 assessment rolls to Frankenlust Township.

Employee Handbook Trustee Britton met with Chad Karsten from Fahey Schultz Burzych Rhodes to review the items that the Board discussed at the October 10, 2023 meeting. It was pointed out that Employees are to be paid weekly, bi-weekly, monthly or bi-monthly not quarterly, as stipulated in the Michigan Payment of Wages and Fringe Benefits Act. Holiday pay was discussed for office staff.
