Public Comments: Scott St

Scott Staszak of Frankenlust Township verbally presented his desire to create a multi-use multi-sports facility at 7294 South Side Saginaw Rd. which appears to fit the uses described in C-2 zoning. The property is zoned C-3. He wanted to make sure that property that is C-3 also includes most or all of what is allowed in C-2 since our ordinances do not specifically state that fact.

A discussion ensued and the consensus of the Planning Commission is that the intention of the ordinances is that C-3 encompass the uses of C-2 and that the fact that the ordinances do not specify that is an oversight in the ordinance wording.

Dave Helmreich **motioned** that the use as explained by Scott Staszak does fit C-3 zoning. Jim Begick seconded. **Motion carried**.

Further consensus of the Planning Commission is that the oversights that appear to exist in the C-3 and Light Industrial descriptions as stated in ordinance 4.11 need to be addressed and that a list of any ordinances that should be addressed be created in the coming Commission meetings and kept by the Secretary for future disposition.

Review and Discuss Bylaws: Review and discussion of proposed Planning Commission Bylaws occurred. Certain

changes to those proposed changes were agreed upon. A Bylaws revision that includes those changes will be made by the Secretary and draft distributed to all Planning Commission members by the following week for their review with the intention of voting on the new Bylaws during the next regular meeting.
