Fire Department. Meeting minutes from June 3, 2021 are on file. A report of the incidents/runs for the department is on file. There were 44 calls in May 2021: 6 Fire, 26 EMS/Rescue, 6 Good Intent, 0 Hazardous Condition, 6 Service Call, 0 Special Incident Type and 0 False Alarms, 0 Severe Weather & Natural Disaster, with YTD total of 156 calls for 2021. A new explorer, John Gerhauser, Jr., has joined the department. There are currently 3 explorers in the program. Extract and Dryer are due to be delivered soon. It will require power and drainage to be installed to hook everything up. Discussion on putting in a concrete slab on the west side of the building to store the plow during off season months or it can be stored off site in a pole barn offered by a Firefighter. Hydrants need to be exercising and the area around them trimmed. Bay County Water and Sewer offers to do it at \$15 per hydrant. We have paid \$5 per hydrant for someone to do it. Motion by Britton/Begick to pay someone \$10 per hydrant to do the flushing, weed trimming, maintenance and painting annually. Roll Call Vote:

<u>Proposal for Fire Chief Position</u>. Fire Chief Kukla provided a detailed presentation that he prepared to the board. There are many items that are required to be done over and above the normal daily, weekly, monthly routines to meet standards at the state and federal levels that haven't been addressed and completed in years, if ever. When completed, those items would help the department run more efficiently and effectively. Fire Chief Kukla is proposing to increase his days working at the township from 2 days to 3 days per week to accomplish these tasks. The board will review the proposal and make a determination when setting the 2021-2022 budget. Trustee Britton, as board liaison to the Fire Department, was asked by the board to meet with Frankenlust Fire Chief, Bryan Kukla, to present questions and concerns expressed by board members.

<u>Nature Park</u>. In partnership with the U.S. Fish and Wildlife and help from Chippewa Nature Center, work was begun on cutting autumn olive (an invasive species) and putting up barricades and fencing. There is more work to be done.

<u>Planning Commission</u>. Reports from May 19, 2021 are on file.

Zoning Administrator. May report on file.

<u>Fiscal Year Resolution</u>. Motion by Britton/Ortner to approve the Resolution to Reconcile Fiscal Year Accounting giving guidelines to costs to be included in each fiscal year. If an expenditure is completed in June, but not billed or paid for until July, it will be accrued for the previous fiscal year. <u>Fund Balance</u>. Road construction on 8 Mile Road will be complete before June 30, 2021. The budget for roads has a balance of \$23,286.36 remaining. Our auditor disclosed that we could take money from the Fund Balance to cover this overage of approximately \$64,000.00. Motion by Campbell/Begick not to exceed \$70,000.00 from Fund Balance to the budget to cover the cost of the road construction on 8 Mile Road, which will be replaced when planning the 2021-2022 fiscal budget. <u>Bay County Water and Sewer</u>. Supervisor Campbell gave the Bay County Water and Sewer permission to send delinquent water bill letters to those affected residents. This letter is for information only to guide them in paying the delinquent bills.

<u>Planning Commission</u>. Alice Eschenbacher has resigned from the Planning Commission after many years of service. Supervisor Campbell has interviewed Cristi Gettel, who has applied for the position. Motion by Campbell/Britton to appoint Cristi Gettel to finish the term of that open position. 5 aye, 0 nay. <u>Land Survey</u>. Assessor, Anissa Zaucha, recommended to require a survey to be done on a land division to verify the correct boundary lines of the parcels.
