1. I will furnish St. Anthony Academy with all necessary documents and forms for the above-named child/children, including: registration form, birth certificate, baptismal certificate, transcripts from previous schools, as well as all other records concerning the medical, academic and disciplinary background of each child. These documents need to be turned in before the beginning of the school year. (The parent of a student who has been previously enrolled at St. Anthony Academy, however, need only provide a pre-registration or registration form unless otherwise notified.)
2. I agree to be obligated for a full year's tuition, even should I choose to withdraw my child from SAA. I understand that SAA will allow me to pay the tuition over ten months but this in no way affects my obligation to pay the full tuition. I further understand that SAA is relying (to its detriment) on this promise of payment in order to provide the resources required for the operation of the school. I also agree to pay the registration and miscellaneous fees (pursuant to the provisions set forth below), and any other fees as may from time to time be assessed for books, special school supplies, and similar expenses.
3. I accept the Academy Discipline and Honor Code and the application thereof. *
4. I accept the Uniform Code and all rules, precepts and policies emanating from the Academy regarding said Code. *
