

## Membership Fees, Terms & Conditions – Version: May 2026

<p><b>1. Annual Structure</b></p>	<p>1.1 Classes operate on a 50-week training year, allowing for a two-week closure at Christmas.</p> <p>1.2 Fees remain payable during the summer holidays as classes continue to run.</p>
<p><b>2. Taster Sessions and Enrolment</b></p>	<p>2.1 We offer one taster session per child who has not previously attended.</p> <p>2.2 After the taster session, you must notify us by email within 48 hours to confirm whether your child wishes to join.</p> <p>2.3 If you choose to enrol, your official start date will be the next scheduled class. Payment for membership, insurance, and any remaining lessons in the month will be taken on this date. Start dates cannot be deferred, and failure to make payment before the next class will result in the space being released.</p> <p>2.4 Taster sessions are non-refundable and non-transferable.</p>
<p><b>3. Monthly Subscription</b></p>	<p>3.1 Your first payment is collected in advance, and by enrolling you agree to pre-authorise recurring monthly payments.</p> <p>3.2 Fees are collected via Direct Debit on a rolling basis until you cancel in writing.</p> <p>3.3 Payments are taken on the 23rd of each month for the following month via GoCardless.</p> <p>3.4 If a payment is returned by your bank, we will contact you to arrange an alternative method.</p> <p>3.5 If a payment fails, we will attempt to collect it once more. If the second attempt is unsuccessful, a £5 administration fee will be added to the outstanding balance.</p> <p>3.6 Please contact us immediately if you experience payment difficulties to avoid your child's place being offered to another member.</p>
<p><b>4. Refunds</b></p>	<p>4.1 Unfortunately, we cannot offer refunds on fees, taster sessions, membership fees, holiday camps, parties, or any other class we offer. Events, shows or competitions cannot be refunded. We advise that you are sure you can attend before committing to an event.</p> <p>4.2 A refund will be offered when we have made an error in calculating any amount due.</p> <p>4.3 Refunds cannot be given on kit orders.</p> <p>4.4 If the club cancels a scheduled class and we are unable to offer a suitable make-up session, a credit or refund will be issued for the cancelled session.</p>
<p><b>5. Club Membership</b></p>	<p>5.1 All gymnasts must hold an active Tumbles Academy of Gymnastics membership, which includes mandatory British Gymnastics insurance.</p> <p>5.2 Membership operates on a 12-month rolling basis from the date of joining.</p> <p>5.3 When upgrading membership, the membership year restarts. You will pay the full upgrade price minus the remaining value of your current membership.</p> <p>5.5 Membership fees are non-refundable if you leave part way through the membership year.</p>

<b>6. Insurance</b>	<p>6.1 Tumbles Academy of Gymnastics is affiliated with British Gymnastics; all gymnasts must hold BG insurance.</p> <p>6.2 Only one taster session is permitted under BG insurance rules.</p> <p>6.3 BG insurance renews annually.</p> <p>6.4 Renewals open one month prior to expiry.</p> <p>6.5 Payment is made via the club.</p>		
<b>7. Injury / Absence</b>	<p>7.1 We do not offer refunds or catch-up lessons for general sickness. For long term medical issues, please contact the office so we can discuss options, although we cannot guarantee adjustments. You will understand that in such cases we are obliged to pay staff and establishment costs for the sessions and there is no opportunity to offer the class to another child.</p> <p>7.2 Missed sessions cannot be transferred to alternative classes.</p>		
<b>8. Cancellation Policy</b>	<p>8.1 Membership continues on a rolling basis until cancelled in writing.</p> <p>8.2 You must email us by the <b>18<sup>th</sup> of the month</b> to stop the next month's payment. No notice period is required, but <b>email confirmation is essential.</b></p>

	<p>8.3 Fees must be paid in full before the start of the month. Late payments incur a £5 administration fee. Failure to pay will result in membership being forfeited</p> <p>8.4 Notice cannot be given verbally, via social media, or at the door. It must be emailed to: <a href="mailto:info@tumbles-gymnastics.co.uk">info@tumbles-gymnastics.co.uk</a></p> <p>8.5 You will receive written confirmation of cancellation, including your final payment and final class date.</p> <p>8.6 Non-attendance in classes will not result in cancellation of your membership nor does it act as notice of termination.</p>
<b>9. Changes to Fees, Classes &amp; Policies</b>	<p>9.4 If a competition/event is the same day as your child's training day no make-up session or rescheduled class will take place.</p> <p>9.1 Members agree to follow all Tumbles Academy of Gymnastics codes of conduct.</p> <p>9.2 Monthly fees may be increased to reflect rising operational costs. Reasonable notice will be provided via email.</p> <p>9.3 If we must cancel a scheduled class, we will attempt to offer a make-up session.</p> <p>9.4 If a competition or event falls on your child's training day, no make-up session will be provided.</p>
<b>10. Health and Safety</b>	<p>10.1 Please ensure your contact and medical details are kept up to date via your Coacha account.</p> <p>10.2 No jewellery is permitted, including stud earrings.</p> <p>10.3 Long hair must be tied back securely with plain elastics only.</p> <p>10.4 No gum, food, or juice in the gym. Water bottles must have sports lids.</p> <p>10.5 Members must follow all Tumbles and British Gymnastics policies.</p>
<b>11. Uniform</b>	<p>11.1 New starters may wear comfortable, suitable clothing.</p> <p>11.2 After one full term (three months), a leotard must be worn.</p> <p>11.3 Female gymnasts must wear a one-piece leotard; male gymnasts must wear a unitard and shorts. Members requiring uniform adjustments for cultural or religious reasons should email the office.</p> <p>11.4 Warm up layers should be worn when entering and exiting the gym.</p> <p>11.5 Squad gymnasts must wear the competition uniform for events.</p> <p>Please see instructions for uniforms for each class in our online Shop: <a href="https://tumbles-gymnastics.co.uk/shop">https://tumbles-gymnastics.co.uk/shop</a></p>
<b>12. Parking</b>	<p>12.1 All members must follow the Car Parking Policy. Parking on double yellow lines is prohibited except for Blue Badge holders</p>
