

TERMS AND CONDITIONS

1. Annual Structure	<p>1.1 The structure is based on a 50-week training year allowing for 2 weeks at Christmas</p> <p>1.2 Fees must be paid during the summer holidays as classes continue</p>
2. Taster Sessions and Enrolment	<p>2.1 If your child hasn't been before and you would like to take them along to try the class, we offer one taster session per child.</p> <p>2.2 On completion of the taster session, we request you notify us via email to let us know if you child would like to join the class or not. We will hold your child's space in the class for a maximum of 48 hours.</p> <p>2.3 If you choose to enrol following the trial session, your official start date will be the date of the next class (the following week). Payment will be taken on your official start date for Membership and Insurance, and any remaining lessons for the month. You are not permitted to choose a starting date following a trial session and failure to pay ahead of the next session will result in the place being offered to someone else.</p> <p>2.4 Taster sessions are non-refundable and non-transferable.</p>
3. Monthly Subscription	<p>3.1 Your first payment will be collected in advance, and you agree to register with us and pre-authorise future payments to allow recurring monthly payments.</p> <p>3.2 Fees are taken via Direct Debit on a rolling basis until you notify us via email that you would like to cancel.</p> <p>3.3 Fees are broken down into 12 equal instalments throughout the year. At Tumbles Academy of Gymnastics, we collect all payments via paperless Direct Debit on the 23rd of the month for the following month using our payment provider: GoCardless.</p> <p>3.4 If your payment is returned by your bank for any reason, we will contact you to request an alternative method of payment.</p> <p>3.5 Any late payments with regard to monthly fees, yearly memberships or affiliations, competitions or other requested payments for services rendered will be charged an administration fee of £5, unless a prior arrangement has been agreed.</p> <p>3.6 Please contact us immediately if you have any issues with making payments to prevent the space being advertised.</p>
4. Refunds	<p>4.1 Unfortunately, we cannot offer refunds on fees, taster sessions, membership fees, holiday camps, parties, or any other class we offer. Events, shows or competitions cannot be refunded. We advise that you are sure you can attend before committing to an event.</p> <p>4.2 A refund will be offered when we have made an error in calculating any amount due.</p> <p>4.3 Refunds cannot be given on kit orders</p>

<div>5. Club Membership</div>	<div><p>5.1 In order for you to attend gymnastics classes, you must also be a member of Tumbles Academy of Gymnastics. By booking onto our classes, you are also pre-authorising payment for Tumbles Annual Membership. As a new participant you will be charged your annual membership fee with your first monthly instalment for classes. This includes mandatory insurance with British Gymnastics.</p><p>5.2 The Membership is an annual rolling term. The annual renewal date will be based on a 12-month rolling term. E.g. <div>6. Insurance</div>	<div><p>6.1 Tumbles Academy of Gymnastics is an affiliated club to British Gymnastics and British Gymnastics stipulate that every gymnast requires to be a member. BG Insurance is covered in your annual membership.</p><p>6.2 As we are affiliated with British Gymnastics, we can cover one taster session only.</p><p>6.3 British Gymnasts Insurance is renewed annually.</p></div>

	<p>6.4 Renewals will open 1 month prior to renew.</p> <p>6.5 Payment is made via the club.</p>
7. Injury / Absence	<p>7.1 We do not offer refunds or catch-up lessons for general sickness, however if it is long term, please call the office to discuss the situation and we will try to be accommodating. You will understand that in such cases we are obliged to pay staff and establishment costs for the sessions and there is no opportunity to offer the class to another child.</p> <p>7.2 We do not allow children to select an alternative class to make-up for a session missed due to illness or injury.</p>
8. Cancellation Policy	<p>8.1 Membership at Tumbles runs on a rolling basis until you notify us that you would like to cancel.</p> <p>8.2 You must inform us in writing by the 18th of the month via email if your child wishes to leave the club and stop training. This is to prevent any further payments being taken. You are not required to give a notice period, but you must inform us via email of your intention to cancel.</p> <p>8.3 Fees must be paid in full before the start of the month. If payment is not received before the stated date an additional £5 will be added to the required fees to cover administration costs. Failure to pay before the start of the month will mean your child forfeiting their membership at the club. If you have any questions, concerns or problems with paying fees please contact the office on info@tumbles-gymnastics.co.uk</p> <p>8.4 Notice to cancel membership cannot be accepted at the club by telephone, telling a coach on the door or via a social media message. It MUST be provided in writing via email. The method of notification is by way of email to: info@tumbles-gymnastics.co.uk. This is to ensure the information is properly documented and input on the central system at the correct date.</p> <p>8.5 You will receive written confirmation of your membership cancellation via email. This will notify you of the final payment date and the final class date for the member. Please retain a copy of this for your records.</p> <p>8.6 Non-attendance in classes will not result in cancellation of your membership nor does it act as notice of termination. As stated in 8.2 you must provide notice in writing if you wish to cancel your membership.</p>
9. Changes	<p>9.1 As a customer and valued member of Tumbles you agree to follow the codes of conduct set out by Tumbles Academy of Gymnastics. At any time, we may need to make reasonable changes to these rules, and you will be notified in advance of any changes.</p> <p>9.2 At any time the monthly session fees may be increased to accommodate price increases of rent, coaches and equipment etc. We will provide you with reasonable notice of any price changes in writing via email.</p>

	<p>9.3 If circumstances out of our control force us to cancel a regular well published class we will attempt to offer a 'make-up' class on an alternative day, time or date to substitute this cancellation.</p> <p>9.4 If a competition/event is the same day as your child's training day no make-up session or rescheduled class will take place.</p>
10. Health and Safety	<p>10.1 For the Safety and Welfare of your child – please make sure we have your up-to-date contact details. Especially mobile phone, email address and medical information. Log-in via your Coach account to amend any details.</p> <p>10.2 No Jewellery permitted, including stud earrings. Please, no face paint or colour hair sprays.</p> <p>10.3 Long hair must be tied back neatly, using a plain elastic hair band, (no hair sharp accessories).</p> <p>10.4 No gum, food, or juice drinks in the gym. Water only with a sports lid.</p> <p>10.5 Adhere to Tumbles Codes of Conduct. Policies and British Gymnastics Policies. Located on our website.</p>
11. Uniform	<p>11.1 New Starters : Please feel free to let the gymnast dress in comfortable and suitable clothing.</p> <p>11.2 After one full term (3 months), a leotard should be purchased. Hair must be tied up securely, no socks.</p> <p>11.2 All female gymnasts are required to wear one-piece leotards only. Gymnasts may wear club shorts/leggings to train. Male gymnasts are required to wear a unitard and shorts. Other clothing presents a potential spotting problem and/or safety issue and is not deemed to be the standard of dress within our sport. No bare midriffs are allowed.</p> <p>11.3 Events: All gymnasts will be required to wear the club uniform for events but can wear any leotard for training sessions.</p> <p>11.4 To help muscles stay warm, gymnasts should wear the warm-up hoodie/zoodie, T-shirt and leggings over their leotard when entering and exiting Tumbles.</p> <p>11.5 Squads are required to wear the competition uniform at competitions and performances.</p> <p>Please see instructions for uniforms for each class in our online Shop: https://tumbles-gymnastics.co.uk/shop</p> <p>Please note that gymnasts seeking amendments to the clothing code due to concerns in relation to their cultural background or religious beliefs should email the Office.</p>
