

RELEASE: The OK Survivor Justice Coalition Celebrates Unanimous (91-0) House Passage of the Oklahoma Domestic Abuse Survivorship Act (HB 1639)

Oklahoma City, OK--On March 22nd, the Oklahoma House of Representatives unanimously voted (91-0) to pass HB 1639, the Oklahoma Domestic Abuse Survivorship Act. The bill must now be considered by the Senate before returning to the House for a final vote.

The Oklahoma Survivor Justice Coalition, formed in mid-2022, has been advocating for the bill and for better treatment for survivors of violence who are in jails and prisons. It is estimated there are between 100-500 people in Oklahoma prisons today who were victims of domestic violence or committed their crimes in direct response to abusive treatment. Today, some members of the coalition reacted to the bill's passage out of the House:

"We are ecstatic that HB 1639 passed out of the Oklahoma House unanimously. This sends a strong message that our legislators understand the impact domestic violence has on our state, and that they are prepared to provide an avenue to justice for criminalized survivors undeserving of excessive prison sentences. This is a crucial first step to addressing the problem. However, any legislation that passes in the name of criminalized survivors must include retroactive sentencing relief for Oklahoma's survivors currently serving excessive sentences. We will be imploring the Oklahoma Senate to place meaningful sentencing relief back into the bill before passage." -- Colleen McCarty, Founding Executive Director, Oklahoma Appleseed Center for Law and Justice
