CONTESTANT ASSUMPTION OF RISK AND WAIVER OF LIABILITY	FEE
The undersigned contestant, and the parent or legal guardian if the contestant is under eighteen (18) years of age, acknowledges that participation in the 2026 Navajo Nation Fair All-Indian Rodeo involves inherent and unavoidable risks. These risks include, but are not limited to, injury, illness, property damage, permanent disability, paralysis, or death resulting from participation in rodeo events, the handling of livestock, horseback riding, arena conditions, equipment, travel, weather, and other activities associated with the event. In consideration for being permitted to participate in the 2026 Navajo Nation Fair All-Indian Rodeo, the contestant voluntarily assumes all risks associated with participation and agrees to release, waive, discharge, and hold harmless the Navajo Nation, Navajo Nation Fair Office (NNFOffice), Zion Enterprises LLC, sponsors, contractors, stock contractors, rodeo officials, judges, timers, announcers, volunteers, employees, agents, and all affiliated organizations from any and all claims, demands, actions, liabilities, damages, losses, costs, or expenses arising out of or related to participation in the event, except to the extent caused by the gross negligence or willful misconduct of the released parties where permitted by applicable law. The contestant certifies that he or she is physically and medically capable of participating in the entered rodeo event(s), has obtained any necessary medical clearance, and agrees to comply with all event rules, safety requirements, and the decisions of rodeo officials. Failure to comply with event rules or directions from event officials may result in disqualification or removal from the event without refund. If the contestant is a minor, the undersigned parent or legal guardian certifies that he or she has legal authority to sign this agreement on behalf of the minor contestant, understands the risks associated with rodeo participation, consents to the minor's participation, and agrees to be bound by the terms of this Assumption of Risk and Waiver of Liability. The undersigned further authorizes emergency medical treatment deemed necessary in the event of illness or injury and accepts responsibility for all related medical expenses. By signing below, the undersigned acknowledges that they have carefully read this Assumption of Risk and Waiver of Liability, fully understand its contents, understand that they are giving up certain legal rights, and voluntarily agree to be bound by its terms.
