How the program works: timelines & requirements

Step 1 - Create a Business plan and secure Letter of Support (2 months) No need to be in Canada.

Step 2- If you would like, apply for work permit (~1 month not including processing time).

Step 3- ensure you have your valid language test results (CLB 5) before application is sent.

Step 4 - Submit your completed application (1 month).

Step 4- ensure you actively engage your business here until application is approved.

Step 5- receive PR and PR Visa (currently 37 months but anticipated to drop significantly).

Maintain PR status. You musthave 2 out of 5 years inside Canada to maintain PR status.

Receive your Canadian
Citizenship. You must have 3 out
of 5 years inside Canada,

Your business must be innovative and scalable.

Up to 5 applicants, and their families may be sponsored by them.

You must demonstrate you have enough capital to sustain your business and family.

You must pass security and health checks.
