Is the Prevention Partnership, Inc. a State of Illinois Official BASSET Provider?

Yes, we are a licensed Provider for the State of Illinois Liquor Control Commission. All training is valid for 3 years anywhere in Illinois.

When do I get my Certificate for Work or My Records?

You receive your certificate **on the same day of the class** if you have registered 24 hours in advance. The State of Illinois will mail you a letter within two weeks and they will add you to the State of Illinois Website where you can print a new one up to three years afterwards if you change jobs, move.

What if I fail the Class?

No one has ever failed our instructor led class in 8 years. Our Instructors will stay with students who do not pass the class and will perform tutoring. Students may also return to retake the test at a later date for no charge up to 30 days if failed.

Illinois State Licensed Provider



The Illinois Beverage Alcohol Seller & Server Education Training (B.A.S.S.E.T) is established under the AUTHORITY and is authorized by Section 3-12(a)(2) and (11) of the Liquor Control Act of 1934 [235 ILCS 5/3-12(a)(2) and (11)] Section 3500.105. The purpose of the BASSET program is to encourage profitable, responsible, and legal alcohol sales and service.

BASSET Certification Law Are You Compliant?

As of July 1, 2018, all servers of alcohol and bouncers who check ID must have their BASSET certification in order to work in Cook County.

All new hires must have certification within a small grace period of being hired. All Illinois BASSET cardholders must renew their certification every three years.
